The work specified in this contract consists of providing all labor, materials, equipment, and incidentals to perform 19.5 acres of clearing and grubbing and 6.0 acres of selective clearing and grubbing (remove and dispose nuisance species, trim, protect, and leave standing desirable trees, and the disposal of all vegetation and debris resulting from this process) at various locations on the Florida's Turnpike (SR 91), MP 100.0 to 200.0.

All Sublet work must be contracted to a small business or businesses as defined by the Department. The subcontractor must also submit a notarized Small Business Affidavit Form provided by the Department prior to the start of work.

Proposal Guaranty of \$500 is required for bids over \$150,000 and may be in the form of a Cashier's check, the BDI Bid or Proposal Bond (Form No. 375-020-16), or the standard Bid or Proposal Bond form (Form No. 375-020-09).

The Contractor shall supply to the Department and keep in force at all times during the term of this Contract, a Performance Bond, provided by a surety authorized to do business in the State of Florida.

Prior to beginning work under this Contract, the Contractor shall submit to the Engineer for approval, two copies of the Contractor's proposed plan and methods for performing the work, including a listing of equipment and personnel anticipated for use.

The Contractor shall perform all work during day hours in accordance with the Turnpike Lane Closure Policy.

The quantities shown on the Bid Price Proposal are approximate and only represent estimated planned requirements based on historical or specific needs. The Department does not guarantee any maximum or minimum quantity, any range of quantities, or the exact quantities shown for each bid item.

For this Contract some sites are identified at the time of letting, the Engineer will issue a Work Document. Work Documents will identify the location, description, amount of work to be accomplished, and the number of calendar days to complete the work.

The pay item for mobilization is described as follows: A Location is defined as item/items of work authorized by a single work order for work to be accomplished within a 5-mile length of highway.

No U-turns shall be permitted as a condition of this Contract, except at Service Plazas.
