The work specified in this contract consists of providing all labor, materials, equipment, and incidentals necessary to perform manual and mechanical trimming/power shearing (Trees and Shrubs) of Sea Grapes and other trees as directed by the Engineer. Access to some locations is very limited; (canal banks, slopes, along ditch line and on/off ramps) and specialized equipment may be required at some job sites.

Work sites are at various locations on the Homestead Extension Florida's Turnpike (SR 821), Milepost (MP) 0.0 to 12.5, and Florida's Turnpike (SR 91), MP 0.0x to 70.0.

Prior to beginning work under this Contract, the Contractor shall submit to the Engineer for approval, two copies of the Contractor's proposed plan and methods for performing the work, including a listing of equipment and personnel anticipated for use.

The Contractor shall perform all work during day hours in accordance with the Turnpike Lane Closure Policy.

No U-turns shall be permitted as a condition of this Contract, except at Service Plazas.

Pruning shall conform to ANSI A300 Part 1 Standards (most recent edition) and the companion publication by the International Society of Arboriculture Best Management Practices: Tree Pruning (most recent edition).
