Contract Descr: EMERGENCY RESPONSE - HEFT

The work specified in this contract consists of providing all labor, materials, equipment and incidentals necessary to perform emergency incident response and service patrol, which includes emergency removal and disposal of non-hazardous materials, debris, and dead animals on the Homestead Extension of Florida's Turnpike (SR 821), Milepost (MP) 0.0 to 46.5, and Florida's Turnpike (SR 91), MP 0.0x to 3.35x.

- Prior to beginning work under this Contract, the Contractor shall submit to the Engineer for approval, two copies of the Contractor's proposed plan and methods for performing the work, including a listing of equipment and personnel anticipated for use.
- Payment for the Mobilization (Emergency) item shall be full compensation for the mobilization and demobilization, labor, material, and equipment necessary for an emergency/routine incident response per location, which includes the removal and disposal of non-hazardous material liquid or non-liquid.

Payment for the Service Patrol item consists of a complete trip through the project limits including both sides of the roadway, medians and paved shoulders. Payment for this item includes a minimum one (1) ton capacity vehicle, one supervisor and one laborer and all labor, materials, and equipment necessary to complete the work and also includes the cost of removing and properly disposing of the debris, including dead animals, vehicle tires and any other debris materials collected during the patrol. Submit a schedule for performing the service patrols. Service Patrol Time shall be based on an 8-hour day.

Payment for the Sweeping (Mechanical) item includes the costs of all materials, labor, tools, equipment and incidentals required to furnish and maintain sweeping equipment.

No U-turns shall be permitted as a condition of this Contract, except at Service Plazas.

The Contractor shall perform all work during day and night time hours and in accordance with the Turnpike Lane Closure Policy.
