This is a Business Development Initiative Contract. The work specified in this contract consists of providing all labor, materials, equipment, and incidentals to perform approximately 30.0 acres of clearing and grubbing and 15.0 acres of selective clearing and grubbing (remove and dispose nuisance species, trim, protect, and leave standing desirable trees, and the disposal of all vegetation and debris resulting from this process) and sodding at various locations on the Florida's Turnpike (SR-91), Mile Post (MP) 200.0 to 309.0, Beachline Expressway (SR-528) MP 0.0 to 8.4, East-West Expressway (SR-408) MP 0 to 0.8, Southern Connector Extension (SR-417) MP 2.0 to 5.0, Seminole Expressway (SR-417) MP 38.0 to 55.0.

Prior to beginning work under this Contract, the Contractor shall submit to the Engineer for approval, two copies of the Contractor's proposed plan and methods for performing the work, including a listing of equipment and personnel anticipated for use.

The Contractor shall perform all work during day hours in accordance with the Turnpike Lane Closure Policy.

The quantities shown on the Bid Price Proposal are approximate and only represent estimated planned requirements based on historical or specific needs. The Department does not guarantee any maximum or minimum quantity, any range of quantities, or the exact quantities shown for each bid item.

For this Contract in which specific sites are not identified at the time of letting, the Engineer will issue a Work Document. Work Documents will identify the location, description, amount of work to be accomplished, and the number of calendar days to complete the work. Some sites are identified at the time of letting (See Attachment).

The pay item for mobilization is described as follows: A Location is defined as item/items of work authorized by a single work order for work to be accomplished within a 5-mile length of highway.

No U-turns shall be permitted as a condition of this Contract, except at Service Plazas.

NO PRE-BID CONFERENCE WILL BE HELD FOR THIS PROJECT.

Bidders must submit the BDI Reference Sheet (Form No. 275-000-02) with the bid. Upload the completed BDI Reference Sheet (Form No. 275-000-02) as a zip file using the "File Attachment Upload" folder in the Expedite application.

The Contractor shall supply to the Department and keep in force at all times during the term of this Contract, a Performance Bond provided by a surety authorized to do business in the State of Florida.
