Florida Turnpike shall be the original and entitled Licensed party to all hardware and software. The Contractor shall have personnel with a minimum of three (3) years experience in performing ITS maintenance work, ITS construction work, and/or signing maintenance work as part of the Contract requirements.

CONTRACTOR EXPERIENCE DOCUMENTATION: Expertise and Experience is required in the performance of Intelligence Transportation Systems (ITS) Maintenance.
