This is a Business Development Initiative Contract. The work specified in this contract consists of providing all labor, materials, equipment, and incidentals necessary to construct a 50' x 55' asphalt speed enforcement pad for Florida Highway Patrol's use adjacent to the northbound outside shoulder and other incidentals as needed on the Florida's Turnpike (SR 91) at Milepost (MP) 293.2.

Prior to beginning work under this Contract, the Contractor shall submit to the Engineer for approval, two copies of the Contractor's proposed plan and methods for performing the work, including a listing of equipment and personnel anticipated for use.

The Contractor shall perform all work during day hours in accordance with the Turnpike Lane Closure Policy.

The quantities shown on the Bid Price Proposal are approximate and only represent estimated planned requirements based on historical or specific needs. The Department does not guarantee any maximum or minimum quantity, any range of quantities, or the exact quantities shown for each bid item.

No U-turns shall be permitted as a condition of this Contract, except at Service Plazas.

NO PRE-BID CONFERENCE WILL BE HELD FOR THIS PROJECT.
