Roadway Reconstruction and Widening
County Road (CR) 510 from 87th Street to west of 82nd Avenue
Indian River County, Florida

The Florida Department of Transportation (FDOT) will conduct a Public Information Workshop for the above-mentioned project within Indian River County and the City of Sebastian. The Public Workshop will be held in-person and virtually on different days. The same information will be presented at both the in-person and virtual workshop, so attending both is not necessary. Staff will be available to answer questions and provide assistance. Questions and comments may also be submitted prior to the workshop by e-mailing the Project Manager. PROJECT PURPOSE

The project will create additional capacity on CR 510 by adding two travel lanes and buffered bicycle lanes as well as pedestrian improvements on both sides of the roadway.

PROJECT IMPROVEMENTS

- CR 510 will be widened to four travel lanes, 7-foot buffered bicycle lanes, and 6-foot wide sidewalks.
- Traffic signal at Treasure Coast Elementary School will be upgraded to mast arms.
- The existing 90-degree bend just west of the elementary school will be reconstructed to provide a flatter curve for a 45 mile per hour design speed.
- Existing bridge will be removed and replaced on a new roadway alignment.

CONSTRUCTION IMPACTS

- Existing roadway will remain open for travel.
- Traffic lane shifts will be required.
- Limited lane closures will occur.
- Driveway and street access will be maintained throughout construction.

CONSTRUCTION INFORMATION

- Project not currently funded for construction in the Department's 5-year work program.
- Construction Cost Estimate: **\$14,421,597**

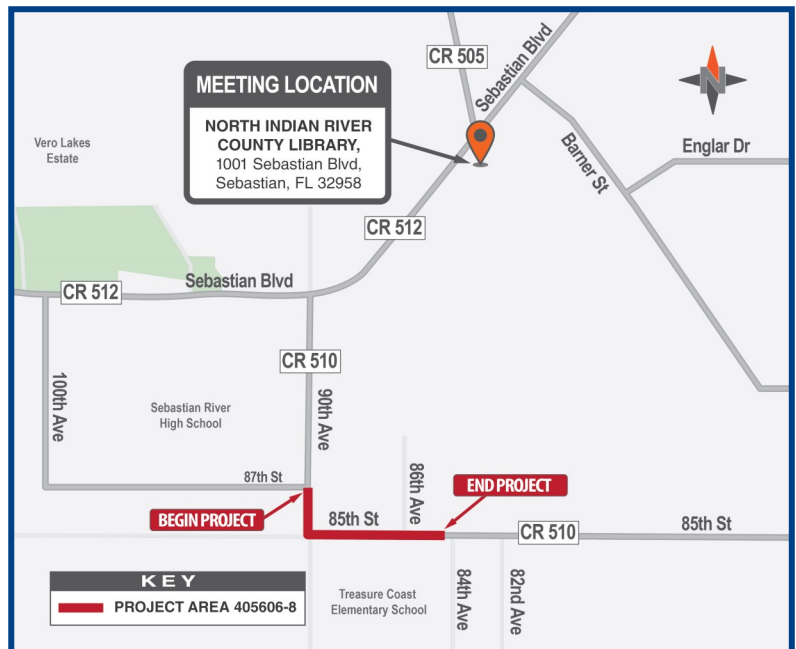
