The Florida Department of Transportation (FDOT), District Four, will conduct a Public Information Workshop regarding the above referenced project. The virtual workshop will have a presentation followed by a question/comment period. Attendees can ask questions and/or make comments via the chat function and project representatives will provide answers during the workshop. Comments and questions may also be emailed to the Project Manager before or after the workshop.

PROPOSED IMPROVEMENTS

- Widen CR 510 from two lanes to four lanes
- Construct 7-foot bicycle lanes and 6-foot sidewalks on both sides of the roadway
- New bridges over the C canal, the L canal and the South Prong Slough
- Construct a roundabout at the intersection of CR 510 and 66th Avenue

CONSTRUCTION INFORMATION

- Construction is currently unfunded in the FDOT 5-year Work Program
- Construction Cost Estimate:
\$52.3 million

CONSTRUCTION IMPACTS

- All work to be done in phases to reduce construction impacts
- No full roadway closures will occur
- Temporary lane closures will occur during non-peak hours
- Access to private property and businesses will be maintained at all times during construction

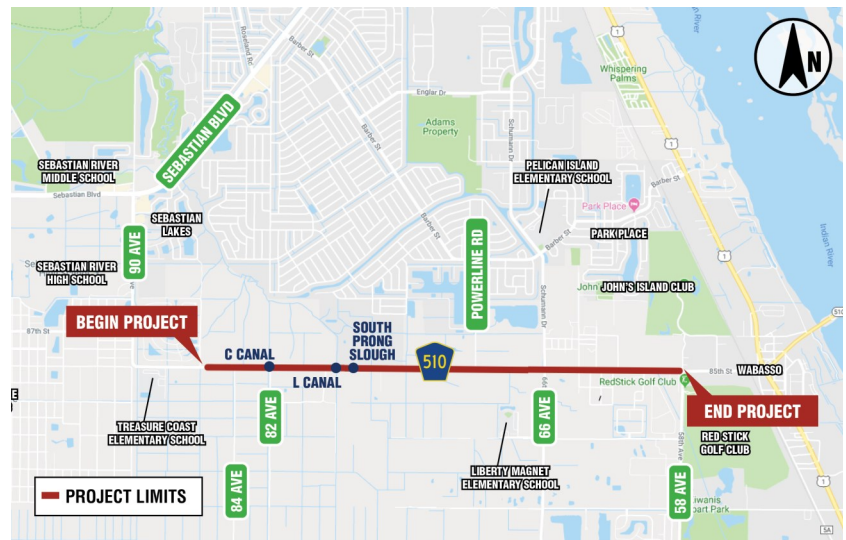
