

- Provided Hundreds of Trips for citizens at Ann & Chuck Dever shelter







Approval of Minutes

The Commission convened a virtual business meeting on March 15, 2022.

The minutes from this meeting are attached to the meeting packet for June 15, 2023.



Alachua County

MV Transportation, Inc., is the CTC for Alachua County.

The Metropolitan Transportation Planning Organization (MTPO) for Gainesville Urbanized Area is the Planning Agency for Alachua County.

The MTPO issued a request for proposals (RFP) on January 4, 2023, and received one response from MV Transportation.

On April 3, 2023, the MTPO recommended MV Transportation continue to serve as the CTC for Alachua County, from July 1, 2023, to June 30, 2028.



Bradford County

Suwannee River Economic Council, Inc. (SREC) is the CTC for Bradford County.

The North Central Florida Regional Planning Council (RPC) is the Planning Agency for Bradford County.

The RPC issued an RFP on January 5, 2023, and received one response from SREC.

On March 23, 2023, the RPC recommended SREC continue to serve as the CTC for Bradford County, from July 1, 2023, to June 30, 2028.



Lafayette County

SREC is the CTC for Lafayette County.

The North Central Florida RPC is the Planning Agency for Lafayette County.

The RPC issued an RFP on January 4, 2023, and received one response from SREC.

On March 23, 2023, the RPC recommended SREC continue to serve as the CTC for Lafayette County, from July 1, 2023, to June 30, 2028.



Holmes and Washington Counties

Tri County Community Council (TCCC) is the CTC for Holmes and Washington Counties.

The Emerald Coast Regional Council (ECRC) is the Planning Agency for Holmes and Washington Counties.

ECRC issued a Request for Interest and Qualifications (RFQ) on October 31, 2022, and received two responses.

On April 20, 2023, ECRC recommended TCCC continue to serve as the CTC for Holmes and Washington Counties, from July 1, 2023, to June 30, 2028.



Walton County

TCCC is the CTC for Walton County.

The Okaloosa-Walton TPO is the Planning Agency for Walton County.

The TPO issued an RFQ on October 31, 2022, and received two responses.

On April 20, 2023, the TPO recommended TCCC continue to serve as the CTC for Walton County, from July 1, 2023, to June 30, 2028.



Hernando County

Mid-Florida Community Services, Inc., is the CTC for Hernando County.

Hernando-Citrus MPO is the Planning Agency for Hernando County.

The MPO began a procurement process on August 19, 2022, and received one response from Mid-Florida Community Services.

On February 2, 2023, the MPO recommended Mid-Florida Community Services continue to serve as the CTC for Hernando, from July 1, 2023, to June 30, 2028.



Indian River County

Senior Resource Association, Inc. (SRA) is the CTC for Indian River County.

The Indian River County MPO is the Planning Agency for Indian River.

The MPO issued an RFP in January 2023, and received one response from SRA.

On April 12, 2023, the MPO recommended SRA continue to serve as the CTC for Indian River, from July 1, 2023, to June 30, 2028.



Sarasota County

Sarasota Board of County Commissioners (BOCC) is the CTC for Sarasota County.

Sarasota-Manatee MPO is the Planning Agency for Sarasota County.

Sarasota BOCC is a governmental entity and not subject to a formal competitive procurement process for continuing as the CTC.

On May 17, 2023, the MPO recommended Sarasota BOCC continue to serve as the CTC for Sarasota County, from July 1, 2023, to June 30, 2028.



St. Lucie County

St. Lucie BOCC is the CTC for St. Lucie County.

St. Lucie TPO is the Planning Agency for St. Lucie County.

St. Lucie BOCC is a governmental entity and not subject to a formal competitive procurement process to bid for continuing as the CTC.

On April 12, 2023, the TPO recommended St. Lucie BOCC continue to serve as the CTC for St. Lucie County, from July 1, 2023, to June 30, 2028.





Innovative Service Development (ISD) Grant – Background

Originally called the Mobility Enhancement Grant (MEG) in 2016-2019, funded at approximately \$2 million.

Funded at \$10 million through the Multi-Use Corridors of Regional Economic Significance (M-CORES) program in 2019-2021.

The program was unfunded for one year (FY2021-22) after M-CORES program was repealed.

2022 Legislature appropriated \$4 million for FY22-23 (through June 30, 2023), which CTD awarded the full amount for 8 projects.

2023 Legislature appropriated \$6 million for FY23-24, **contingent on Governor's approval:**

- A CTC can be awarded only one project per service area.
- A project serving a single (county/multi-county) service area can be awarded up to \$750,000. A project serving multiple service areas can be awarded up to \$1.5 million.



ISD Grant – Application and Review Process

CTD facilitated the application process from February 3 to May 12, 2023:

- Two training webinars on February 8 and April 6.
- "Early Bird" proposals submitted by March 17.

CTD received 14 applications, requesting \$5.7 million, for FY23-24:

- All 8 current year projects re-applied.
- 4 proposed new projects (Highlands, Lake, and 2 in Putnam).
- 2 proposed projects (Union and St. Lucie) previously awarded under MEG or M-CORES.
- 2 proposals (Putnam and St. Lucie) were submitted during "Early Bird" but were still considered in the review process.

The Review Subcommittee convened on May 31, 2023, and recommends approval of 12 projects, total of \$4.9 million, for FY 2023-24...

AOR Study Update

- CTCs are required to collect data on TD services in Annual Operating Report (AOR).
- CTD study examining ways to improve AOR data accuracy and analyses.
- Created an advisory workgroup made up of CTC, Planner, and Agency representatives.
- Held public workshop on May 25 requested stakeholder feedback.
- Launched web page to test alternative approach with collecting data (June 1-22).
- Final report anticipated to be presented at CTD Meeting in August.





