Call to Order

Chair Stevens called the meeting to order. Executive Director David Darm called the roll. A quorum was present.

Pledge of Allegiance

Chair Stevens led the Pledge of Allegiance.

Welcome and Introductions

Chair Stevens invited the Commissioners and Advisors to introduce themselves. He informed participants that the meeting was being recorded and all feedback received, including comments within the webinar chat box, will be reflected in the meeting minutes.

Public Comments

No public comments were received.

Approval of September 15, 2023, Meeting Minutes

Chair Stevens asked for a motion to approve the minutes from the September 15, 2023, meeting.

ACTION TAKEN: Commissioner Knight moved, and Commissioner Tellez seconded the motion, to approve the minutes from September 15, 2023, meeting. The motion carried unanimously.

Approval of 2024 Commission Business Meeting Schedule

Chair Stevens explained that the Commission is required to meet at least four times a year and publish its meeting dates and locations for members of the public to attend. Mr. Darm presented the tentative dates and locations for each of those meetings: January 18, 2024, in Tallahassee (in conjunction with legislative awareness day at the Capitol; March 20, 2024, location to be

determined; June 5, 2024, in Tampa (in conjunction with the Professional Development Workshop); September 23, 2024, in West Palm Beach (in conjunction with the Commission's annual training conference); December 11, 2024, for a virtual meeting to approve the 2024 Annual Performance Report.

Chair Stevens asked for a motion to approve the tentative business meeting schedule for 2024:

ACTION TAKEN: Commissioner Gray moved, and Commissioner Knight seconded the motion, to approve the CTD 2024 Commission Business Meeting Schedule. The motion carried unanimously.

Approval of the 2023 Annual Performance Report (APR)

Chair Stevens and David Darm explained that each year the CTD is required to present its Annual Performance Report (APR) to the Governor and Legislature on January 1 each year (s.427.013(13), F.S.). This includes performance data on TD services reported by the Coordinated System during previous fiscal years (July 1, 2022, to June 30, 2023). Mr. Darm explained that the APR provides two perspectives: the **Macro, Systemwide View-** All services provided by the Coordinated System, captured in CTC Annual Operating Reports (AORs); and the **Micro, Programmatic View-** All non-sponsored services, funded by CTD Trip & Equipment (T&E) Grant, captured on CTC approved invoice data. Mr. Darm shared some of the major accomplishments in FY22-23 included the restoring funding to Innovative Service Development Grant; receiving additional budget authority during legislative session; and conducting the AOR study.

Casey Perkins, representing Thomas Howell Ferguson, explained that out of the four years of data collected from the Trip & Equipment Grant, FY22-23 has the greatest number of trips being 1.4 million in total. On average, FY19-20 saw around 7,000 trips a day, whereas in FY22-23 the average number of trips were just above 6,000 a day. He shared that the County Profiles will be accompanied in this year's APR, to better understand the trips taken and any details about the trips.

Chair Stevens asked for a motion to approve the 2023 Annual Performance Report.

ACTION TAKEN: Commissioner Barrios moved, and Commissioner Knight seconded the motion, to approve the 2023 Annual Performance Report. The motion carried unanimously.

Innovative Service Development (ISD) Grant Program – Proposed Rule and Budget Changes

Chair Stevens advised that Commission had two more action items on the agenda, both relating to the ISD Grant Program. He asked Executive Director Darm to provide a brief overview of the items. Mr. Darm explained that the ISD Grant is a competitive grant that is awarded to Community Transportation Coordinators (CTCs) to test new and innovative ways of serving the transportation disadvantaged population. He stated that the program has undergone a series of changes and fluctuations in funding over the years:

- Originally called the "Mobility Enhancement Grant", the program was funded on a nonrecurring (one fiscal year) basis between \$1 and \$2 million for the first three years (FY 2016-17 – 2018-19).
- In 2018, the Commission renamed it the "Innovation and Service Development Grant" and established program criteria in Rule 41-2.014, F.A.C.
- In FY 2019-20 and 2020-21, the ISD Grant was funded at \$10 million on a recurring (yearover-year) basis under the Multi-Use Corridors of Regional Economic Significance (M-CORES) Program, which included new statutory provisions that amended the program's objectives from what was in the CTD rule.

- In FY 2021-22, the Legislature repealed the M-CORES program, which resulted in the ISD Grant not being funded for one year.
- The Legislature funded the ISD Grant at \$4 million in FY 2022-23 and \$6 million in FY 2023-24, both on a nonrecurring basis, under the General Appropriations Act (GAA). This included legislative proviso with similar program requirements that were in the M-CORES statutes, with slight adjustments that included funding caps for approved projects.

He explained that the CTD rule language pertaining to the ISD Grant has not been updated since 2018, prior to the passage of the M-CORES legislation. The program's current requirements are governed by legislative budget proviso. Because of this, Mr. Darm presented that Rule 41-2.014, F.A.C., be amended to update the language to similar provisions that have been implemented through legislative proviso in the GAA of FY22-23 and 23-24. The proposed changes included:

- Amending the name "Innovation and Service Development" to "Innovative Service Development" and clarifying that grant funds are for "innovative service delivery that is cost efficient for the program and time efficient for the users."
- Allowing for CTCs to work with non-traditional providers, such as transportation network companies, to deliver door-to-door, on-demand, or scheduled transportation services;
- Limiting a CTC to receive one grant award for a designated service area and capping funding at \$750,000 for a project serving a single service area and \$1.5 million for a regional project serving multiple service areas;
- Updating the program objectives to include the following:
 - o Increase a TD rider's access to life-sustaining activities;
 - Enhance regional connectivity and cross-county mobility; or,
 - Reduce the difficulty in connecting transportation disadvantaged persons to a transportation hub and from the hub to their final destination.
- Requiring a 10% local match of grant recipients; and
- Deleting subsection (7) and replacing with subsection (4)(c) to include the ISD Grant under the provisions of distribution of grant funds.

He explained that, if approved by the Commission, these changes would take effect July 1, 2024.

Mr. Darm also advised the Commission that, in addition to these proposed rule changes, the Commission had a legislative budget request (LBR) that included \$4 million in recurring funding to the ISD Grant program. He stated that while the requested amount is \$2 million less than what was appropriated in the current fiscal year, the LBR more closely aligned with expenditure patterns of the program. Mr. Darm explained the chart that was provided in the meeting package that showed the last four fiscal years of ISD Grant funding: during the last grant application cycle, the CTD contracted with Thomas Howell Ferguson P.A. to conduct an analysis of the program's performance and provide a summary report. Out of the last four years of the program's funding, "the total awarded amounts easily reached \$4 million but also struggled to surpass much beyond \$5 million. In other words, looking over these four years of the ISD Grant program's history, the overall demand for grant awards appears relatively stable at no more than \$5 million annually, regardless of the total appropriation amount." The report stated, "the competitiveness of the application process overall increases when project applicants are chasing after fewer available grant dollars."

Chair Stevens asked for a motion to approve the recommended changes to the Rule.

ACTION TAKEN: Commissioner Tellez moved, and Commissioner Barrios seconded the motion, to approve the recommended changes to the Rule. The motion carried unanimously.

Impact of Time-Limit Options on ISD Projects

Mr. Darm explained that the Commission currently does not limit the number of years a project can be funded under the ISD Grant Program. While applicants have been allowed to request funding for multiple years, all projects are funded on a state fiscal year cycle and must reapply to be considered eligible for funding in subsequent years. He explained the intent of the program was to allow projects to introduce something that is new or improved to the local community. He provided the Commission with the definition of "innovate" and explained that while a service may require several years to develop and test, there comes a point in time when a project can no longer be considered "new."

The ISD Review Subcommittee convened and discussed options for limiting the number of years a project could be considered eligible for future grant cycles, which would impact both current and future projects. The Commission was presented with three options to consider for limiting the number of years an ISD Grant project could be considered eligible for funding, which was included in the Commission Meeting Packet for December 11, 2023. Executive Director Darm gave a quick overview of the options and the current projects that (if approved) would not be considered eligible for funding after June 30, 2024 under each option: 1) a 5-year limit would impact projects in Hernando, Pinellas (Late-Shift), and St. Lucie Counties; 2) a 4-year limit would impact projects in Hernando, Martin, Pinellas (Late-Shift), and St. Lucie Counties; and 3) a 3-year limit would impact projects in Hernando, Indian River/St. Lucie, Martin, Pinellas (Late-Shift), and St. Lucie.

A discussion followed. Chair Stevens asked for a motion to approve an option for limiting the number of years a project can be considered eligible for funding under the ISD Grant.

ACTION TAKEN: Commissioner Barrios moved, and Commissioner Knight seconded the motion, to approve a 4-year limit (Option 2) on the eligibility of ISD Grant Projects. The motion carried unanimously.

Legislative Budget Request for FY2024-25

Executive Director Darm explained that the CTD is requesting a total of \$5 million in additional recurring budget authority to the Grants and Aids category to support funding for the following programs:

- ISD Grant- \$4 million
- Planning Grant- \$1.9 million
- Shirley Conroy Capital Assistance Grant- \$1.9 million
- Trip & Equipment Grant- \$53.4 million

The Legislature will consider this request as part of the 2024 Legislative Session (January 9 – March 8, 2024).

Fiscal Year 2023-24 Goals and Progress- Executive Director Report

Mr. Darm provided a progress report on the following goals for State Fiscal Year 2023-24:

Goal 1- Fill all CTD staff positions, implement salary raises, and adjust position descriptions as needed to better align employee strengths with program needs. Mr. Darm stated that all CTD staff positions have been filled (including a new data analyst position that was created in FY23-24) and salary raises have been applied.

Goal 2- Develop Statewide Five-Year Transportation Disadvantaged Plan pursuant to s. 427.013(15), F.S.- Mr. Darm said this goal was in progress.

Goal 3- Fill all CTD board seats and improve agency engagement- Mr. Darm said the CTD is working with the Governor's Office to address this goal.

Goal 4- Test run the collection of disaggregated data as part of the AOR- Mr. Darm said the CTD staff are working with the Florida Department of Transportation-Office of Information Technology to explore next steps for testing the data collection.

Goal 5- Assess Quality Assurance review process and identify changes needed to improve program performance.- Mr. Darm said they would be providing a presentation at a future Commission meeting.

Public Comments

No public comments were received.

Closing Remarks and Adjournment

No remarks or comments were received. Chair Stevens asked for a motion to adjourn.

ACTION TAKEN: Commissioner Barrios moved, and Commissioner Tellez seconded the motion, to adjourn the meeting. The motion carried unanimously.

VII. 2024 Legislative Session Wrap-Up

BACKGROUND:

The Florida Legislature concluded the 2024 Regular Session on March 8. During this 60-day period, the Legislature passed the General Appropriations Act for Fiscal Year 2024-25 and CS/CS/SB 1380 (CS/CS/HB 1673) related to paratransit services to persons with disabilities and the transportation disadvantaged.

BUDGET IMPACTS:

The Legislature appropriated approximately \$59.3 million to the grants and aids category of the Transportation Disadvantaged Trust Fund. This funding will be distributed through the following grant programs:

- Approximately \$52.9 million to the Trip & Equipment (T&E) Grant Program.
- Approximately \$1.9 million to the Planning Grant Program.
- \$1.4 million to the "Shirley Conroy" Capital Equipment Grant.
- \$3 million to the Innovative Service Development (ISD) Grant.

The funding for the ISD Grant is \$1 million less than what the CTD originally requested for FY24-25. The amount was lowered to prevent a \$1 million reduction to the T&E Grant, which was projected in the House and Senate's original budget proposals. The funding for the Planning Grant represents a 5% increase equivalent to raises that were applied to state employees as set by the Legislature in FY23-24 (pursuant to Rule 41-2.014(4)(a), F.A.C.). Funding for the Shirley Conroy Grant remains the same as the previous year.

The projected T&E Grant funding allocations for each county are attached to this document. ISD Grant project proposals for FY24-25 funding are due to the Commission on April 30, 2024, and the Commission is expected to approve projects at the June Commission Business Meeting.

LEGISLATION IMPACTS:

CS/CS/SB 1380 makes several changes to Chapter 427, Florida Statutes, including:

- Amends the Commission board membership (s. 427.012, F.S.), from 7 to 11 members appointed by the Governor.
- Creates two new sections (ss. 427.02 and 427.021, F.S.), defining "Transportation Service Provider" as an organization or entity that contracts with a local government to provide paratransit service to persons with disabilities.
- For contracts entered into or renewed with local governments on or after October 1, 2024, transportation service providers will be required to:
 - Provide training to paratransit drivers that meet minimum requirements established by the Agency for Persons with Disabilities (APD).
 - Establish reasonable time periods between a request for service and the arrival of the transportation service provider.

- Provide transparency regarding the quality of paratransit services, including data related to the timeliness of services and the handling of complaints.
- All contracts with paratransit service providers (on or after October 1, 2024) must be competitively procured and may not be awarded using an exceptional purchase provision (provided for in s. 287.057(3), F.S.).
- Requires the CTD to establish model procedures for transportation service providers and local governments to receive and investigate reports related to adverse incidents during the provision of paratransit services to persons with disabilities.

The bill also amends the Florida Department of Transportation (FDOT) requirements governing transit services (s. 341.041(16), F.S.) to ensure all its grants and agreements related to paratransit services, unless otherwise directed by federal and state law, include:

- Performance requirements for the delivery of services, including clear penalties for repeated or continuing violations;
- Minimum liability insurance requirements for all transportation services purchased, provided, or coordinated for the transportation disadvantaged through contracted vendors or subcontractors; and
- Complaint and grievance processes for paratransit users, including a requirement that all reported complaints, grievances, and resolutions are reported to FDOT on a quarterly basis.

Finally, the bill requires the following entities to deliver comprehensive reports by January 1, 2025:

- FDOT Conduct a comprehensive review of the CTD and Coordinated TD System, including services delivered by CTCs, how other paratransit services are coordinated, breakdowns of funding, etc. The report is due to the Governor and Legislature.
- University of South Florida-Center for Urban Transportation Research (CUTR) Deliver a report to FDOT on model policies and procedures or best practices for timeliness of paratransit services.
- Implementing Solutions from Transportation Research and Evaluating Emerging Technologies (I-STREET) Living Lab – Conduct a comprehensive review on technology and training improvements to better support persons with disabilities using paratransit services administered under federal, state, or local governments. The report is due to FDOT, the Governor and Legislature.

If the bill is approved by the Governor, it will take effect upon becoming law. The enrolled bill text is attached to this analysis.

If the bill is approved, the Commission will adopt rules and develop procedures to implement the new requirements of the bill (ss. 427.02 and 427.021, F.S.). CTD will also work with FDOT, APD, and other entities named in the bill to assist with their responsibilities.

VIII. Annual Operating Report (AOR) Study

BACKGROUND

Each year, the Commission is required to collect data on transportation operations related to serving the Transportation Disadvantaged (TD) population in the State of Florida (s. 427.013(1), F.S.). These data are collected in an aggregated (summarized) format and submitted by Community Transportation Coordinators (CTCs) within their AOR (due September 15th), which the Commission then compiles within its Annual Performance Report submitted to the Governor and Legislature on January 1st, pursuant to s. 427.013(12), F.S.

The Commission contracted with Thomas Howell Ferguson (THF) to assist in facilitating a study to help improve the accuracy and analyses of performance data reported in the AOR. In September 2023, THF presented a report, which recommended the Commission conduct an official test run for the collection of disaggregated, individual trip level data, as well as individual bus pass level data, from CTCs as part of the 2023 AOR submission cycle. By collecting disaggregated data instead of just annual trip totals, the verifiability of the AOR and its capacity to be used for deeper and more extensive analyses are enhanced. The full report can be accessed at: <u>CTD Home (fdot.gov)</u>.

STUDY UPDATE

In October 2023, CTD staff met with THF and the FDOT-Office of Information Technology (OIT) to discuss plans to facilitate the test run for the collection of disaggregated AOR data. Currently, FDOT-OIT assists the Commission in managing its Data Collection System (DCS), where AOR data are submitted and stored. FDOT-OIT informed CTD that it would need to submit a Technology Proposal to host the collection of disaggregated data within the DCS or a similar system. CTD submitted its Technology Proposal in December 2023. In January 2024, FDOT-OIT and CTD met again where it was recommended that CTD and THF develop a working prototype for the online submission of disaggregated data from CTCs.

In March 2024, four CTC service areas agreed to test run the online submission of their AOR data to the working prototype: Palm Beach County (large urban), Indian River and Martin Counties (small urban), and Glades-Hendry Counties (rural). THF developed a secure online submission process to collect disaggregated AOR data from the participating CTCs. THF will work with the CTCs to verify and analyze the data. Once the testing of these four service areas is completed, CTD will identify additional service areas to test run.

Casey Perkins, from Thomas Howell Ferguson, will provide an update on the progress of the test run at the Commission meeting on March 20, 2024.

Commission for the Transportation Disadvantaged (CTD) Priorities and Scheduled Activities for Remainder of FY 2023-24

Priority Issues:

- Innovative Service Development (ISD) Grant This is a competitive grant program for Community Transportation Coordinators (CTCs) to test new, innovative projects serving the transportation disadvantaged (TD). The Legislature appropriated \$3 million to the ISD Grant program for FY 2024-25. Applications are due to CTD on April 30, the review subcommittee is expected to recommend projects in May, and the Commission to approve FY24-25 funding in June 2024 [refer to grant schedule on following page].
- Annual Operating Report (AOR) Study The CTD collects data from CTCs each year on transportation operations related to serving the TD population, which are compiled within the annual report to the Governor and Legislature. The Commission is currently testing the collection of disaggregated data to improve the verification and analyses of services reported in the AOR. The study will conclude with a final report presented to the Commission (due June 30, 2024).
- "Shirley Conroy" Rural Area Capital Assistance Grant This is a competitive grant program for CTCs to purchase capital equipment (vehicles, technology, etc.) used in service of the TD population. The Florida Department of Transportation (FDOT) transfers \$1.4 million each year for the CTD to award funding to Shirley Conroy Grant projects. Applications are due to CTD on May 31, the review subcommittee is expected to recommend projects in June, and the Commission to approve FY24-25 funding in July 2024 [refer to grant schedule on following page].
- Implementation of Legislation (if approved by Governor) The Florida Legislature passed CS/CS/SB 1380 (CS/CS/HB 1673) related to paratransit services to persons with disabilities and the transportation disadvantaged. The bill amends the Commission board membership, creates new statutory requirements for transportation service providers (ss. 427.02 and 427.021, F.S.), and requires several comprehensive reports. If approved, the bill takes effect upon becoming law. Some of the actions that would be required of the Commission include:
 - Host a Commission meeting for new board members, once appointed, to introduce them to the TD Program and their responsibilities.
 - Develop and adopt rules (Chapter 41-2, F.A.C.) to implement new requirements for local government contracts with transportation service providers (s. 427.02, F.S.) and model procedures for reporting of adverse incidents with paratransit services to persons with disabilities (s. 427.021, F.S.) (due October 1, 2024).
 - Assist FDOT with gathering information related to the CTD and TD Program as part of the comprehensive report to the Governor and Legislature (due January 1, 2025).
