# Approval of Minutes

## Shirley Conroy Grant FY 2024-25

Each year, FDOT transfers \$1.4M for the CTD to award competitive grants to CTCs for the purchase of capital equipment.

CTD released applications on March 15, with a deadline to submit on May 31, 2024:

Twenty applications were received, requesting a total of \$2.6M.

Technology related requests included: 4 for scheduling software; 2 for cameras/video recording software; 1 for computers

1 for maintenance equipment and

14 requests were for purchase of vehicles.

CTD met with FDOT on June 27 to review applications and prepare recommendations.

CTD prioritized technology requests to promote efficiencies and safety. Vehicle recs based on age, mileage and status of FDOT grants.

# AOR Study Report



#### Background

CTD is required to "compile all available information on the transportation operations for and needs of the transportation disadvantaged [TD] in the state" (s. 427.013(1), F.S.)

Community Transportation Coordinators (CTCs) provide this information in their Annual Operating Report (AOR) to CTD on September 15 each year.

AOR data are collected in an aggregated (summarized) format and includes total trips provided during the previous state fiscal year (July 1 – June 30).

CTD compiles the AOR data within its Annual Performance Report, which is submitted to the Governor and Legislature on January 1 each year, pursuant to s. 427.013(13), F.S.

For two years, CTD contracted with Thomas Howell Ferguson (THF) to conduct a study toward improving the accuracy and analyses of AOR data.

In September 2023, THF presented its first report, and the Commission approved a recommendation to test the feasibility of collecting more disaggregated (detailed) data on trips, miles and bus passes in the AOR.

In 2024, THF created a prototype website and approximately ten CTCs participated in testing the submission of their disaggregated data. THF submitted its second report in June 2024.



#### Recommendations

CTD still needs to complete a comprehensive review of its legal options and authorities, as recommended and approved in September 2023:

- Chapter 427 is silent on specific data that can be collected by CTD.
- However, there may be other federal/state laws (e.g., HIPAA) that need examination as part of the collection of personal identifiable data.

CTD also may need additional funding and resources to store a larger volume of data within its Data Collection System.

With these considerations, the Commission should work to fully transition toward collecting disaggregated data (on individual trips and bus passes) as part of the AOR, beginning July 1, 2025 (FY 2025-26).

# Update on SB 1380: New Requirements for Paratransit Services (ss. 427.02 and 427.021, FS)

Defines "transportation service provider" as an entity that contracts with a local government to provide paratransit services for persons with disabilities. This may include:

- Transportation operators that contract with a CTC-local government entity, such as a Board of County Commissioners, to provide paratransit services to TD riders (eligible based on their disability); and/or
- Transportation providers that contract with a fixed route system, which is administered by a local government, to provide ADA complementary paratransit services to eligible persons with disabilities.

Requires transportation service provider drivers to undergo training that meet minimum requirements established by the Agency for Persons with Disabilities (APD), effective on or after October 1, 2024.

Requires CTD to establish model procedures for transportation service providers to receive and investigate reports related to adverse incidents, which must include:

- A periodic review of ongoing investigations and documentation of final outcomes thereof.
- The investigation must commence within 48 hours after receipt of the report.
- Local governments/transportation service providers must submit quarterly reports to the Commission.
