The Florida Department of Transportation consists of seven districts and the Florida's Turnpike Enterprise.

The work program is developed through these districts working with local governments, metropolitan planning organizations, other agencies, and the public.

After work program, public hearings are held in each FDOT district.

Public comments have been accepted, local governments have endorsed the plan, and the Florida Transportation Commission and state legislators have approved it.

The official five-year work program is adopted by the Secretary of the Florida Department of Transportation on July 1, the first day of the state's fiscal year.

As FDOT develops and updates each year's work program with residents and government partners, It is understood that next July 1st, the current year of the plan is complete, and a new fifth year will be added on.

The yearly update produces the new tentative five-year work program.

The work program assures we have a prioritized program of transportation choices that result in a better quality of life for the residents and visitors to this beautiful state.
