REQUIREMENTS


The new Florida Administrative Code rules regarding digitally signed and sealed documents went into effect November 3. 2015. To comply with the new requirements of Rule Chapter 61G15-23.004, the Department will require all plan sets to be modified as described below. These new requirements are included in Volume 2, Chapter 3 of the Plans Preparation Manual to be released on January 1, 2016.

IMPLEMENTATION

The following requirements will apply to all plan sets beginning with the March letting.

- 1. Modify the note placed along the right edge of each sheet as follows (changes highlighted): "THE OFFICIAL RECORD OF THIS SHEET IS THE ELECTRONIC FILE DIGITALLY SIGNED AND SEALED UNDER RULE 61G15-23.004, F.A.C.".
- 2. Modify the Digital Signature Appearance shown on the Signature Sheet to include additional notes located above and below the signer's name required by the new rule as shown on the following page:
