This bulletin announces the release of *Standard Plans, Interim Revision IR700-102-1* and editorial revisions to the *2021 Traffic Engineering Manual (TEM)* which updates signs *FTP-40-06* and *FTP-41-06* within *Standard Plans, Index 700-102* (*Special Sign Details*) in the *FY 2021-22 Standard Plans* and associated references in *TEM*, *Section 2.21 (FLORIDA LITTER LAW SIGNS)*.

## **REQUIREMENTS**

**Standard Plans, Index 700-102** has been updated and is released as a **Standard Plans Interim Revision (IR 700-102-1)** to the **FY 2021-22 Standard Plans**. The Interim Revision will replace the original version of the Index published on October 30, 2020; therefore, a reference to the Interim Revision is not required on the Key Sheet under the Governing Standard Plans.

This update requires the following editorial changes in <u>**TEM</u>**, Section 2.21 (FLORIDA LITTER LAW SIGNS):</u>

- References to "FTP-40-06" change to "FTP-40-21"
- References to "*FTP-41-06*" change to "*FTP-41-21*"
- References to "*FTP-41-04*" change to "*FTP-41-21*"

# **COMMENTARY**

This *Standard Plans Interim Revision* is intended to address the update to the Florida Litter Law, Florida Statute 403.413, that increased the minimum civil penalty from \$100 to \$150. This update requires the replacement of sign details for *FTP-40-06* and *FTP-41-06* on *Standard Plans, Index 700-102*, Sheets 5 and 6 with new sign details *FTP-40-21* and *FTP-41-21*, respectively.

### **IMPLEMENTATION**

This change is effective on projects with a letting on or after July 1, 2021. These requirements may be implemented immediately at the discretion of the Districts.
