Name: Melissa Hollis Date: 8/10/2023 COMMENT: 700-120, Sheet 3 of 15 (new sheet): References to "base" should be changed to "transformer base", to be consistent with specs, APL, and other standard plans sheets.

(new RR Crossbuck): MUTCD figure has red strip on front, white strip on back of POST, AND 8B03 (07) A strip of retroreflective white material not less than 2 inches in width shall be used on the back of each blade of each Crossbuck sign for the length of each blade, at all grade crossings where Crossbuck signs have been installed, except those where Crossbuck signs have been installed back-to-back.

Section 700 does not appear to address the WHITE strip on the back of the support, only the back of the crossbuck blades. Please verify.

**RESPONSE:** Agreed. We will update the draft to "Transformer Base." Also agree regarding the white strip on the back of the post. We will adjust the note in the index to make it clear that the back strip must be white.

**COMMENT:** I would not recommend the 'when flashing' with the W10-1 unless it is supported by MUTCD or research. The 'when flashing' implies that the condition only applies when the lights are flashing. It seems as though the associated advance warning sign for a grade crossing is always applicable and not just when flashing.

**RESPONSE:** I agree with your concern. We will remove the "When Flashing" sign from the new assembly.






