COMMENT: 711-003 sheet 2 of 8, TWO-LANE PARALLEL-TYPE ENTRANCE WITH ADDED LANE: When multiple lanes of an entrance ramp are provided and incrementally end, please review against section 2C.42 of Part 2C of the MUTCD if the Lane Ends Sign W4-2 is needed. We get this comment from the Districts on major interstate reconstruction projects where 2 or 3 lane ramps merge the main line and some of these lanes are gradually eliminated.

**RESPONSE:** The chevrons are not being removed, just the diagonals leading up to them on the entrance ramp. They are not required per the AASHTO Greenbook.

**COMMENT:** We acknowledge chevron markings on shoulders prior to the gore area and within the gore area of an entry ramp are not required by AASHTO and are optional in the MUCTD. We (D4 PLEMO-District Interchange Review Coordinator) prefer the markings to remain in the standard index as a measure to prevent undesired driver behavior. In Southeast Florida, drivers are seen frequently using the gore areas and auxiliary lanes for entry ramps as passing lanes along congested segments of interstate and Turnpike. Per MUTCD, these markings may be used to discourage travel on certain paved areas such as shoulders and gore areas.

**RESPONSE:** The chevrons are not being deleted. The 18" diaginals are being removed because they are not shown, even as an option, in the MUTCD and therefore there is no criteria on how to show them. As always, the Standard Plans are not the only avenue to show pavement markings. If you feel that extra pavement markings are needed on projects, they can be included in the Signing and Pavement Marking Plans.
