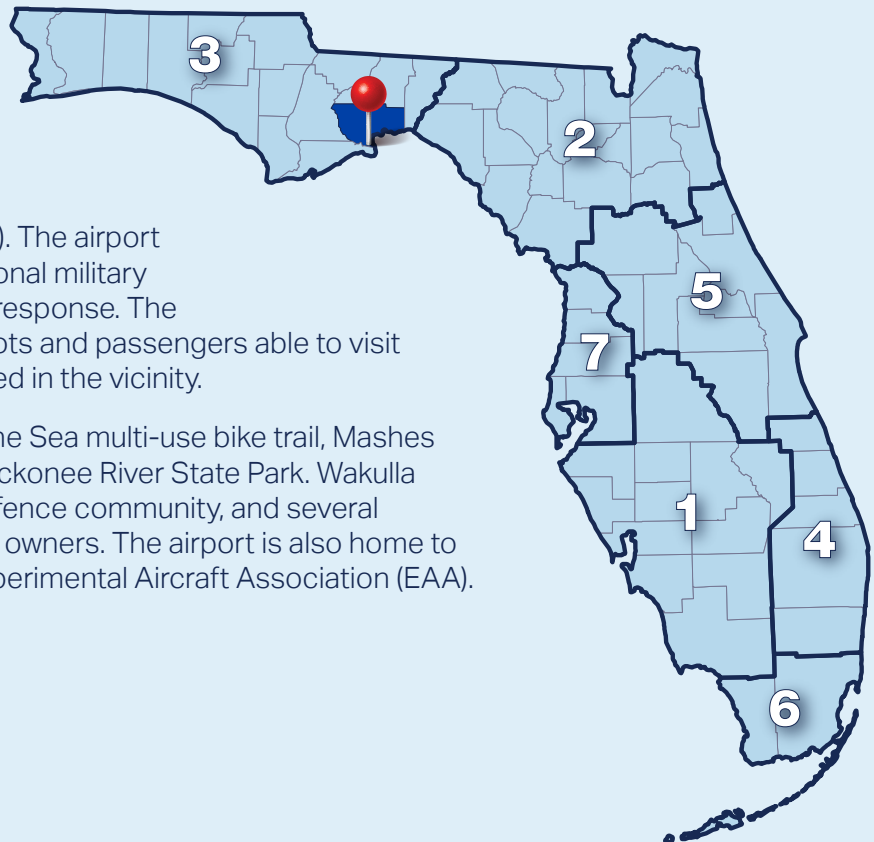

Wakulla County Airport (2J0) is a general aviation airport located west of U.S. Highway 98 and north of the Ochlockonee Bay in Panacea.

The airport has one turf runway that is 2,590 feet long by 70 feet wide (Runway 18-36). The airport commonly supports recreational flying, occasional military operations, medical evacuations, and disaster response. The airport is also a destination for tourists, with pilots and passengers able to visit the many bayside restaurants and shops located in the vicinity.

Other local attractions include Capital City to the Sea multi-use bike trail, Mashers Sands Beach, Bald Point State Park, and Ochlockonee River State Park. Wakulla County Airport hosts a residential through the fence community, and several homes offer on-site hangars for private aircraft owners. The airport is also home to an active local chapter (Chapter 445) of the Experimental Aircraft Association (EAA).

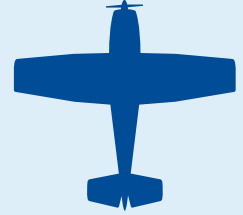

Overview of the FASP 2043 Update:

Per Florida statute, the Florida Aviation System Plan (FASP) is periodically updated to summarize the airport and aviation needs in Florida while remaining consistent with the goals of the Florida Transportation Plan (FTP). The FASP 2043 Update focuses on reviewing the applicability of the various goals, objectives, and performance measures to support two primary goals: 1) provide for more efficiency in decision making within FDOT to support funding and development decisions, and 2) provide airports within the system with recommendations for development that support their individual missions while contributing to the overall strength and health of the Florida airport system.
