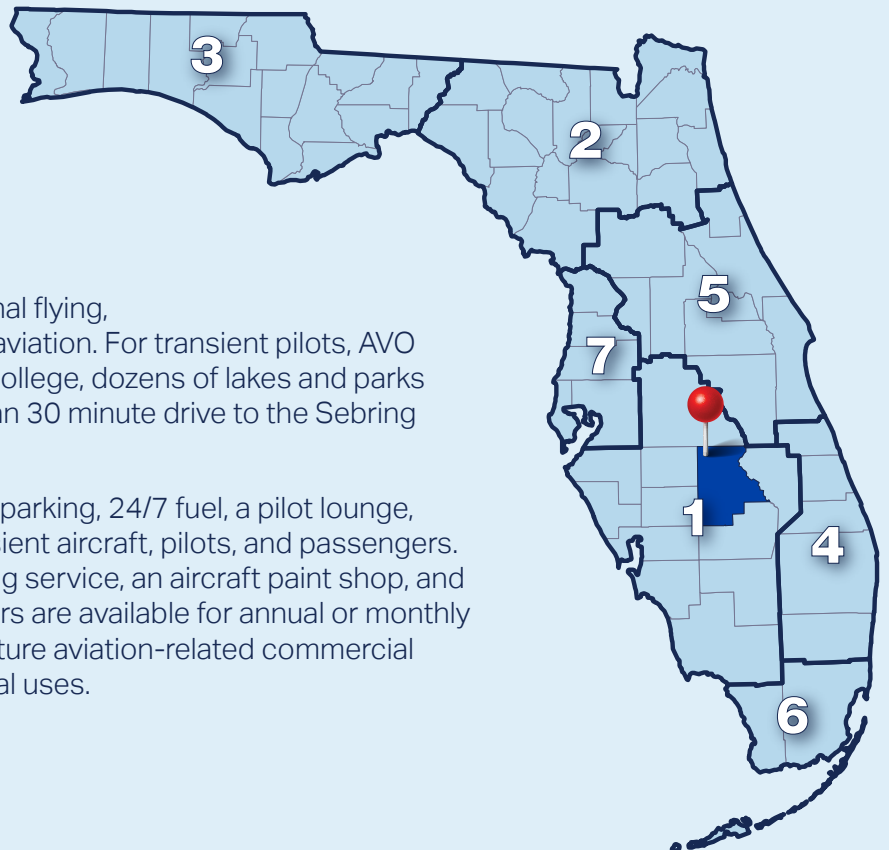

Avon Park Executive Airport (AVO) is a general aviation (GA) airport located directly west of the City of Avon Park in central Florida. The airport provides two paved runways (5-23 and 10-28), the longest of which is 5,374 feet long by 100 feet wide.

The airport primarily accommodates recreational flying, agricultural spraying, and corporate/ business aviation. For transient pilots, AVO provides quick access to South Florida State College, dozens of lakes and parks near the Avon Park/Sebring area, and a less than 30 minute drive to the Sebring International Raceway.

AVO's fixed-base operator (FBO) offers aircraft parking, 24/7 fuel, a pilot lounge, and other aviation services for based and transient aircraft, pilots, and passengers. Other onsite businesses include a crop spraying service, an aircraft paint shop, and an aircraft maintenance shop. Multiple T-hangars are available for annual or monthly leases. Developable land is also available for future aviation-related commercial activities, industrial expansion, or other potential uses.

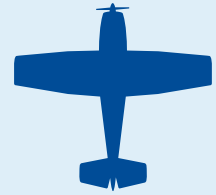

Overview of the FASP 2043 Update:

Per Florida statute, the Florida Aviation System Plan (FASP) is periodically updated to summarize the airport and aviation needs in Florida while remaining consistent with the goals of the Florida Transportation Plan (FTP). The FASP 2043 Update focuses on reviewing the applicability of the various goals, objectives, and performance measures to support two primary goals: 1) provide for more efficiency in decision making within FDOT to support funding and development decisions, and 2) provide airports within the system with recommendations for development that support their individual missions while contributing to the overall strength and health of the Florida airport system.
