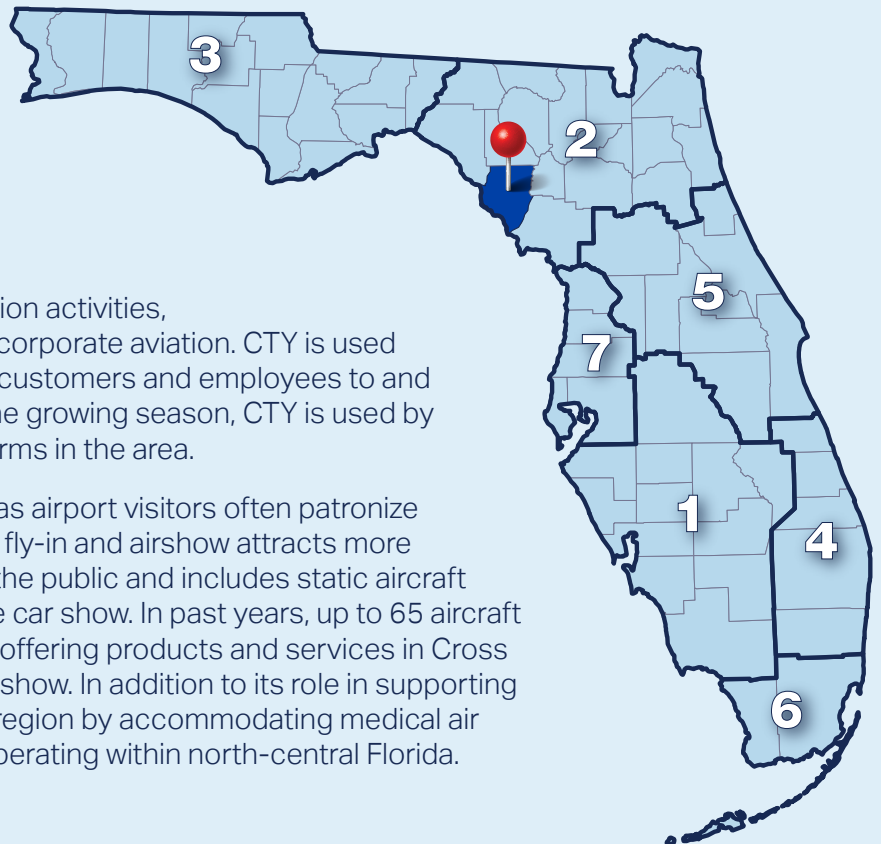

Cross City Airport (CTY) is a publicly owned, public-use general aviation (GA) airport in north-central Florida located one mile east of Cross City. CTY has two paved runways (Runway 4-22 and Runway 13-31). Runway 4-22 is 5,005 feet long and 75 feet wide and is the longest runway at CTY.

As a GA airport, CTY supports a variety of aviation activities, including recreational flying, flight training, and corporate aviation. CTY is used by several local and nonlocal businesses to fly customers and employees to and from Cross City on corporate aircraft. During the growing season, CTY is used by agricultural sprayers to apply fertilizer to tree farms in the area.

The airport is a catalyst for the local economy, as airport visitors often patronize restaurants and hotels in the vicinity. An annual fly-in and airshow attracts more than 3,500 visitors to CTY. The event is free to the public and includes static aircraft displays, military demonstrations, and a vintage car show. In past years, up to 65 aircraft have flown into the event, and 100 businesses offering products and services in Cross City and nearby towns have participated in the show. In addition to its role in supporting local economic activity, CTY assists the entire region by accommodating medical air transportation and search and rescue flights operating within north-central Florida.

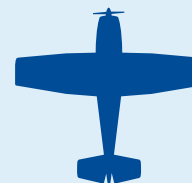

Overview of the FASP 2043 Update:

Per Florida statute, the Florida Aviation System Plan (FASP) is periodically updated to summarize the airport and aviation needs in Florida while remaining consistent with the goals of the Florida Transportation Plan (FTP). The FASP 2043 Update focuses on reviewing the applicability of the various goals, objectives, and performance measures to support two primary goals: 1) provide for more efficiency in decision making within FDOT to support funding and development decisions, and 2) provide airports within the system with recommendations for development that support their individual missions while contributing to the overall strength and health of the Florida airport system.
