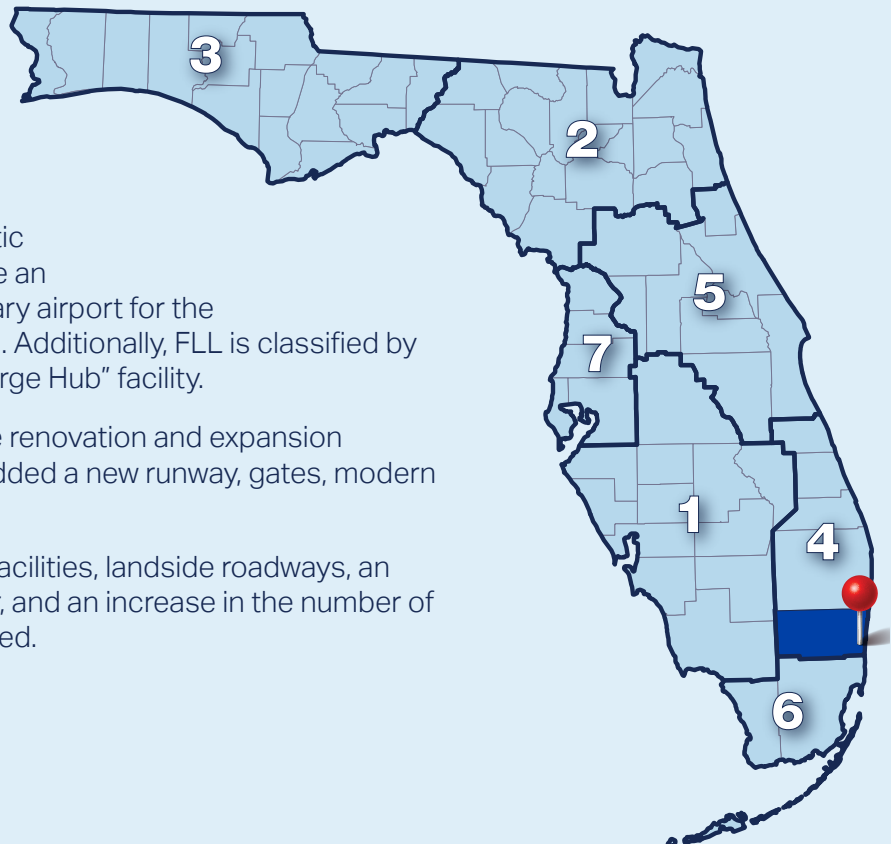


The Fort Lauderdale/Hollywood International Airport (FLL) is a major public airport in Broward County and one of three airports serving the South Florida metropolitan area.

With more than 700 daily flights to 135 domestic and international destinations, FLL has become an intercontinental gateway. FLL serves as a primary airport for the Greater Fort Lauderdale area and South Florida. Additionally, FLL is classified by the US Federal Aviation Administration as a "Large Hub" facility.

As of 2022, the airport completed an extensive renovation and expansion project worth approximately \$3 billion, which added a new runway, gates, modern terminals, and new shops and restaurants.

A future Master Plan will result in new terminal facilities, landside roadways, an intermodal center, an automated people mover, and an increase in the number of aircraft gates from 66 to 95 when fully completed.

Overview of the FASP 2043 Update:

Per Florida statute, the Florida Aviation System Plan (FASP) is periodically updated to summarize the airport and aviation needs in Florida while remaining consistent with the goals of the Florida Transportation Plan (FTP). The FASP 2043 Update focuses on reviewing the applicability of the various goals, objectives, and performance measures to support two primary goals: 1) provide for more efficiency in decision making within FDOT to support funding and development decisions, and 2) provide airports within the system with recommendations for development that support their individual missions while contributing to the overall strength and health of the Florida airport system.
