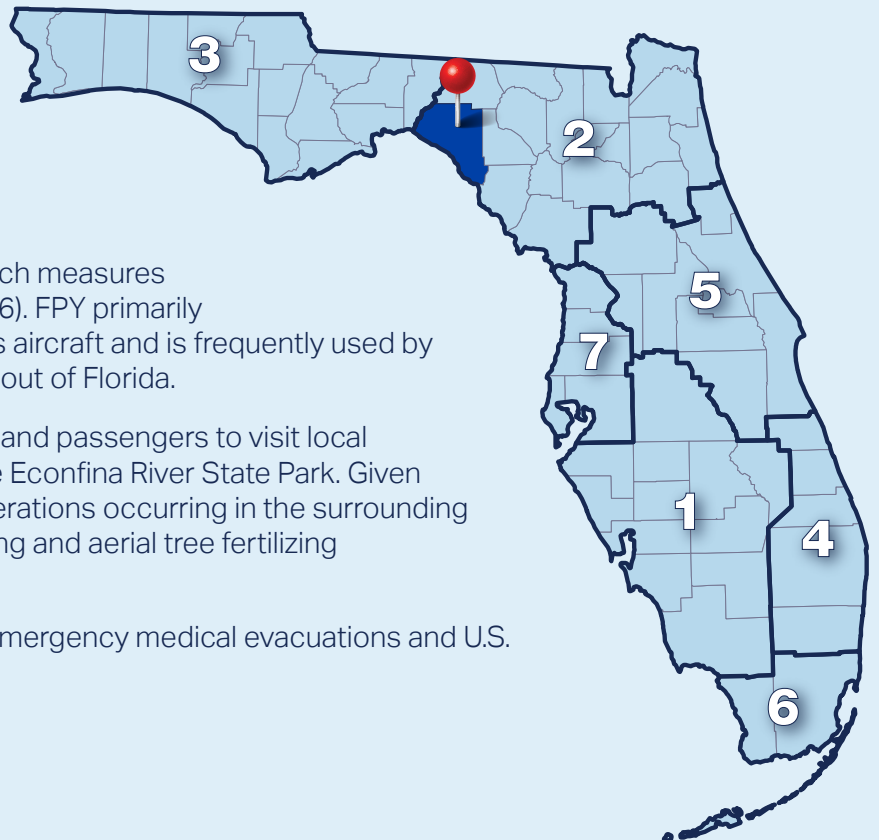

Perry-Foley Airport (FPY) is a general aviation (GA) airport in north-central Florida located three miles south of the City of Perry. FPY is operated by Taylor County and serves several communities in the area.

FPY has two paved runways, the longest of which measures 5,013 feet long by 100 feet wide (Runway 18-36). FPY primarily serves recreational GA and corporate/business aircraft and is frequently used by transient aircraft to refuel while traveling in and out of Florida.

The airport offers a courtesy car to allow pilots and passengers to visit local restaurants and natural attractions, such as the Econfinia River State Park. Given the high number of logging and agricultural operations occurring in the surrounding region, FPY frequently hosts agricultural spraying and aerial tree fertilizing operations.

FPY also supports critical missions, including emergency medical evacuations and U.S. Forest Service fire patrols.

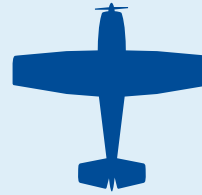

### Overview of the FASP 2043 Update:

Per Florida statute, the Florida Aviation System Plan (FASP) is periodically updated to summarize the airport and aviation needs in Florida while remaining consistent with the goals of the Florida Transportation Plan (FTP). The FASP 2043 Update focuses on reviewing the applicability of the various goals, objectives, and performance measures to support two primary goals: 1) provide for more efficiency in decision making within FDOT to support funding and development decisions, and 2) provide airports within the system with recommendations for development that support their individual missions while contributing to the overall strength and health of the Florida airport system.
