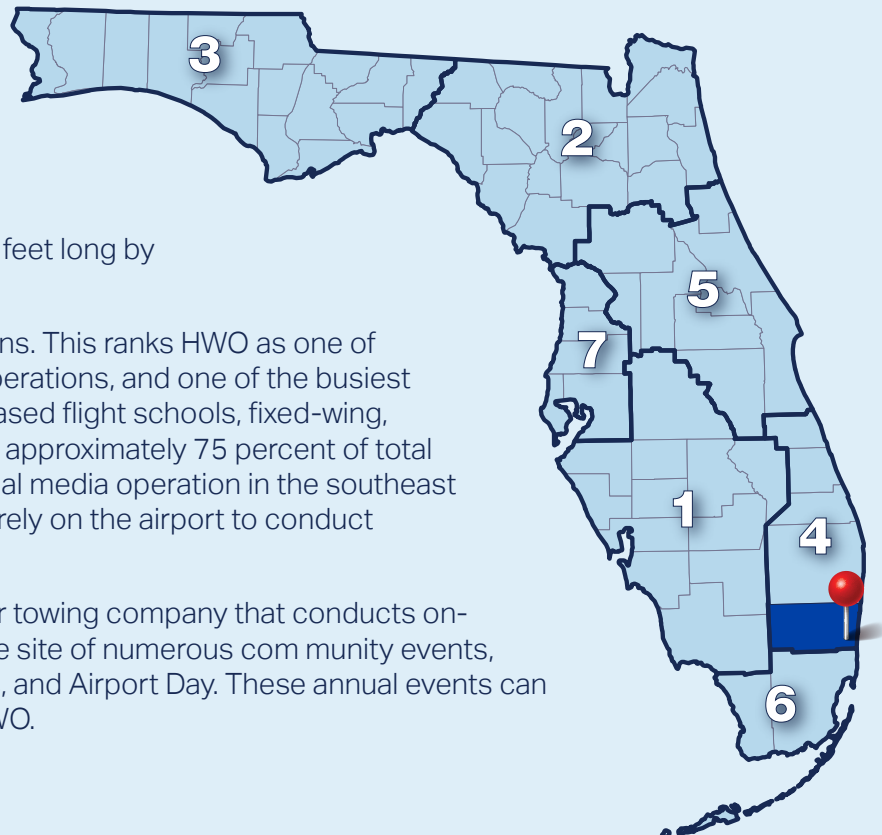

North Perry Airport (HWO) is a general aviation (GA) airport located approximately 10 miles southwest of downtown Fort Lauderdale in Hollywood. The airport is owned and operated by Broward County. HWO offers four paved runways, the longest of which measures 3,350 feet long by 100 feet wide (Runway 1L-19R).

In 2023, HWO recorded over 230,000 operations. This ranks HWO as one of the busiest GA airports in Florida in terms of operations, and one of the busiest GA airports in the United States. With eleven based flight schools, fixed-wing, and rotorcraft flight training activities comprise approximately 75 percent of total operations. HWO also supports the largest aerial media operation in the southeast U.S. Several news channels in Broward County rely on the airport to conduct helicopter operations.

HWO is also the headquarters of a large banner towing company that conducts on-demand services in 49 states. The airport is the site of numerous community events, including Young Eagles Day, Wings and Wheels, and Airport Day. These annual events can each attract approximately 4,000 visitors to HWO.

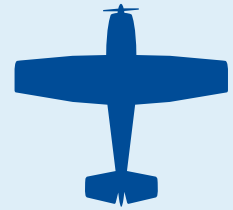

## Overview of the FASP 2043 Update:

Per Florida statute, the Florida Aviation System Plan (FASP) is periodically updated to summarize the airport and aviation needs in Florida while remaining consistent with the goals of the Florida Transportation Plan (FTP). The FASP 2043 Update focuses on reviewing the applicability of the various goals, objectives, and performance measures to support two primary goals: 1) provide for more efficiency in decision making within FDOT to support funding and development decisions, and 2) provide airports within the system with recommendations for development that support their individual missions while contributing to the overall strength and health of the Florida airport system.
