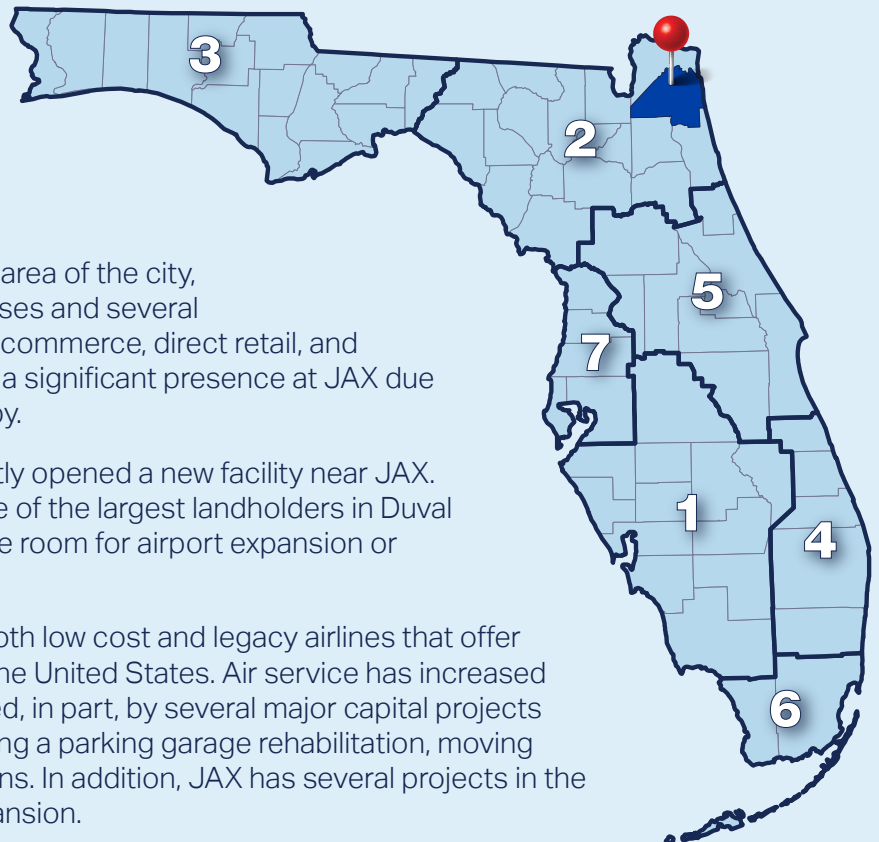

Jacksonville International Airport (JAX) is a commercial service airport located in north Jacksonville. JAX offers two paved runways (8-26 and 14-32), the longest of which measures 10,000 feet long by 150 feet wide.

Situated within an industrial and retail-oriented area of the city, the airport supports numerous nearby businesses and several onsite tenants, including those involved with e-commerce, direct retail, and warehousing/distribution. FedEx and UPS have a significant presence at JAX due to numerous distribution centers located nearby.

The Department of Veterans Affairs also recently opened a new facility near JAX. The Jacksonville Aviation Authority (JAA) is one of the largest landholders in Duval County. As a result, the airport has considerable room for airport expansion or commercial development.

Scheduled passenger service is provided by both low cost and legacy airlines that offer nonstop access to many destinations across the United States. Air service has increased in recent years. This growth has been supported, in part, by several major capital projects to improve passenger support facilities, including a parking garage rehabilitation, moving walkway replacement, and bathroom renovations. In addition, JAX has several projects in the design phase, including a notable terminal expansion.

Overview of the FASP 2043 Update:

Per Florida statute, the Florida Aviation System Plan (FASP) is periodically updated to summarize the airport and aviation needs in Florida while remaining consistent with the goals of the Florida Transportation Plan (FTP). The FASP 2043 Update focuses on reviewing the applicability of the various goals, objectives, and performance measures to support two primary goals: 1) provide for more efficiency in decision making within FDOT to support funding and development decisions, and 2) provide airports within the system with recommendations for development that support their individual missions while contributing to the overall strength and health of the Florida airport system.
