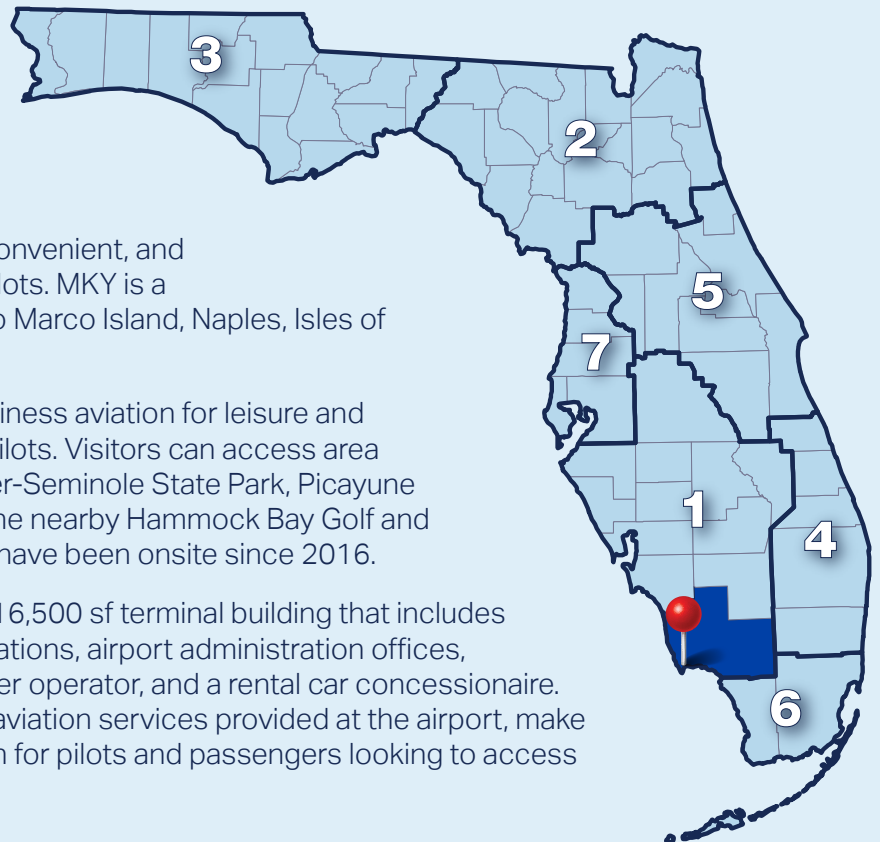

Marco Island Executive Airport (MKY) is a general aviation (GA) airport located approximately five miles north of Marco Island. The airport provides one paved runway that is 5,000 feet long by 100 feet wide (Runway 17-35). The airport offers uncongested airspace to provide a pleasant, convenient, and safe flight experience for new and seasoned pilots. MKY is a gateway for GA pilots and their passengers into Marco Island, Naples, Isles of Capri, and much of southwest Florida.

MKY frequently accommodates corporate/business aviation for leisure and business travelers, as well as recreational GA pilots. Visitors can access area attractions including numerous beaches, Collier-Seminole State Park, Picayune Strand State Forest, and golf resorts such as the nearby Hammock Bay Golf and Country Club. Additionally, three flight schools have been onsite since 2016.

Opened in March of 2021, MKY boasts a new, 16,500 sf terminal building that includes a pilot and passenger lounge, flight planning stations, airport administration offices, lease space for tenant businesses, an air charter operator, and a rental car concessionaire. These amenities, along with the wide range of aviation services provided at the airport, make Marco Island Executive Airport an ideal location for pilots and passengers looking to access southwest Florida.

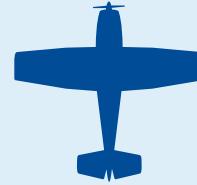

### Overview of the FASP 2043 Update:

The FASP 2043 Update focuses on reviewing the applicability of the various goals, objectives, and performance measures to support two primary goals: 1) provide for more efficiency in decision making within FDOT to support funding and development decisions, and 2) provide airports within the system with recommendations for development that support their individual missions while contributing to the overall strength and health of the Florida airport system.
