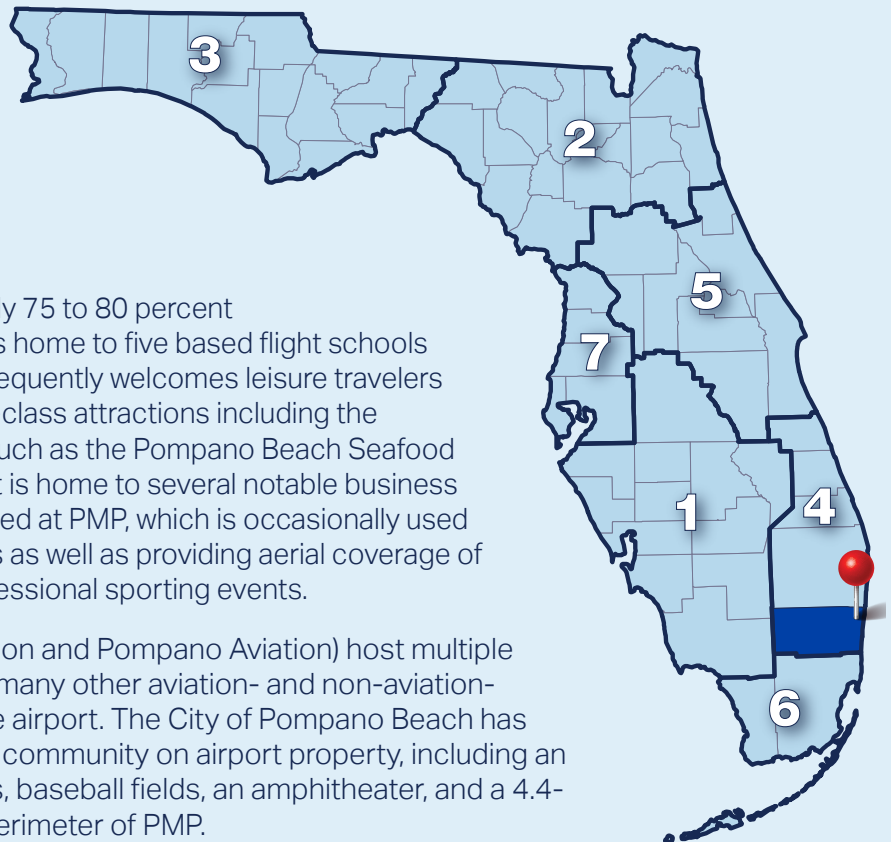

Pompano Beach Airpark (PMP) is a city-owned general aviation (GA) airport located approximately eight miles north of downtown Fort Lauderdale. The airport has three paved intersecting runways, the longest of which measures 4,918 feet long by 150 feet wide (Runway 15-33).

Flight training activities account for approximately 75 to 80 percent of the airport's total operations, and the airport is home to five based flight schools for both fixed wing and rotor aircraft. PMP also frequently welcomes leisure travelers who are drawn to area beaches and other world-class attractions including the Pompano Beach Fisher Family Pier and events such as the Pompano Beach Seafood Festival. Located in southeast Florida, the airport is home to several notable business tenants. Goodyear's "Wingfoot Two" blimp is based at PMP, which is occasionally used for the Daytona 500, NFL, NBA, and MLB Games as well as providing aerial coverage of PGA Championship tournaments and other professional sporting events.

Two fixed base operators (FBOs) (Sheltair Aviation and Pompano Aviation) host multiple aircraft maintenance and repair providers, and many other aviation- and non-aviation-related business tenants are also located at the airport. The City of Pompano Beach has developed several recreational facilities for the community on airport property, including an aquatics center, tennis courts, pickleball courts, baseball fields, an amphitheater, and a 4.4-mile bike and jogging track that encircles the perimeter of PMP.

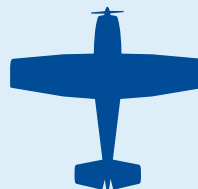

Overview of the FASP 2043 Update:

Per Florida statute, the Florida Aviation System Plan (FASP) is periodically updated to summarize the airport and aviation needs in Florida while remaining consistent with the goals of the Florida Transportation Plan (FTP). The FASP 2043 Update focuses on reviewing the applicability of the various goals, objectives, and performance measures to support two primary goals: 1) provide for more efficiency in decision making within FDOT to support funding and development decisions, and 2) provide airports within the system with recommendations for development that support their individual missions while contributing to the overall strength and health of the Florida airport system.
