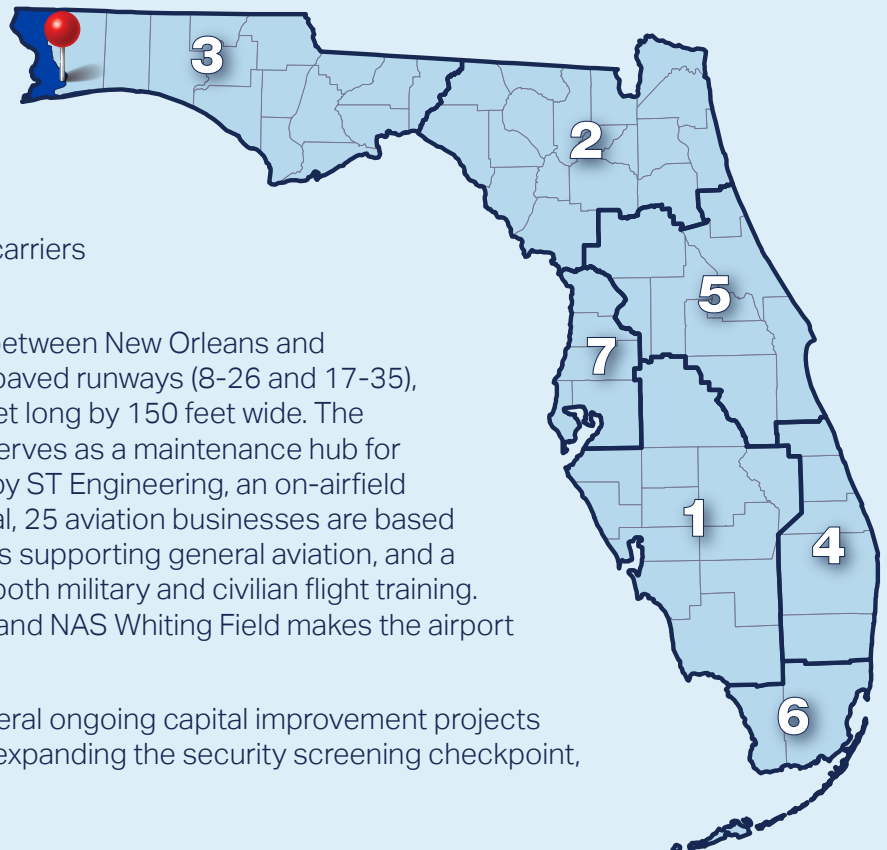

Pensacola International Airport (PNS) is in the beautiful Emerald Coast City of Pensacola and is one of the fastest growing commercial service airports in the country. The airport is served by seven airlines including American, Delta, United, Southwest, and several ultra-low-cost carriers providing service to 19 nonstop destinations.

PNS is the largest commercial service airport between New Orleans and Jacksonville. The airport has two intersecting, paved runways (8-26 and 17-35), both of which measure approximately 7,000 feet long by 150 feet wide. The airport is home to a UPS air cargo facility and serves as a maintenance hub for UPS aircraft. Aircraft maintenance is provided by ST Engineering, an on-airfield MRO that employs 1,700 workers locally. In total, 25 aviation businesses are based at the airport including two fixed base operators supporting general aviation, and a Part 141 flight training academy that provides both military and civilian flight training. Proximity to Naval Air Station (NAS) Pensacola and NAS Whiting Field makes the airport critical in supporting naval flight training.

To meet passenger growth, the airport has several ongoing capital improvement projects including a new 5-gate passenger concourse, expanding the security screening checkpoint, and extending the commercial airline apron.

### Overview of the FASP 2043 Update:

The FASP 2043 Update focuses on reviewing the applicability of the various goals, objectives, and performance measures to support two primary goals: 1) provide for more efficiency in decision making within FDOT to support funding and development decisions, and 2) provide airports within the system with recommendations for development that support their individual missions while contributing to the overall strength and health of the Florida airport system.
