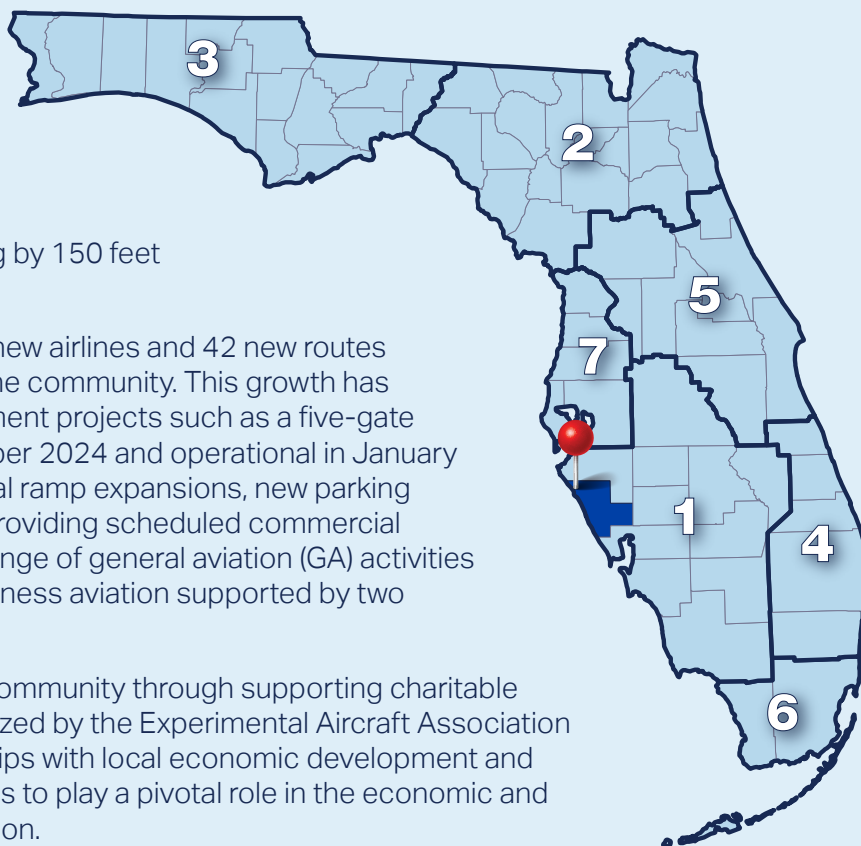

Sarasota Bradenton International Airport (SRQ) is one of the state's fastest-growing commercial service airports, located between the beautiful Gulf Coast cities of Sarasota and Bradenton. The airport offers two paved intersecting runways, the longest of which is 9,500 feet long by 150 feet wide (Runway 14-32).

Between 2018 to 2023, the airport added five new airlines and 42 new routes which brought significant tourism dollars into the community. This growth has been supported by numerous capital improvement projects such as a five-gate terminal expansion to be completed in December 2024 and operational in January 2025, a new inline baggage system, commercial ramp expansions, new parking facilities, among other projects. In addition to providing scheduled commercial service, SRQ accommodates air cargo and a range of general aviation (GA) activities including recreational flying and corporate/business aviation supported by two existing fixed base operators (FBOs).

SRQ strongly values its relationships with the community through supporting charitable groups and hosting Young Eagles flights organized by the Experimental Aircraft Association (EAA). SRQ strives to maintain active partnerships with local economic development and tourism partners to ensure the airport continues to play a pivotal role in the economic and cultural development of its community and region.

## Overview of the FASP 2043 Update:

Per Florida statute, the Florida Aviation System Plan (FASP) is periodically updated to summarize the airport and aviation needs in Florida while remaining consistent with the goals of the Florida Transportation Plan (FTP). The FASP 2043 Update focuses on reviewing the applicability of the various goals, objectives, and performance measures to support two primary goals: 1) provide for more efficiency in decision making within FDOT to support funding and development decisions, and 2) provide airports within the system with recommendations for development that support their individual missions while contributing to the overall strength and health of the Florida airport system.
