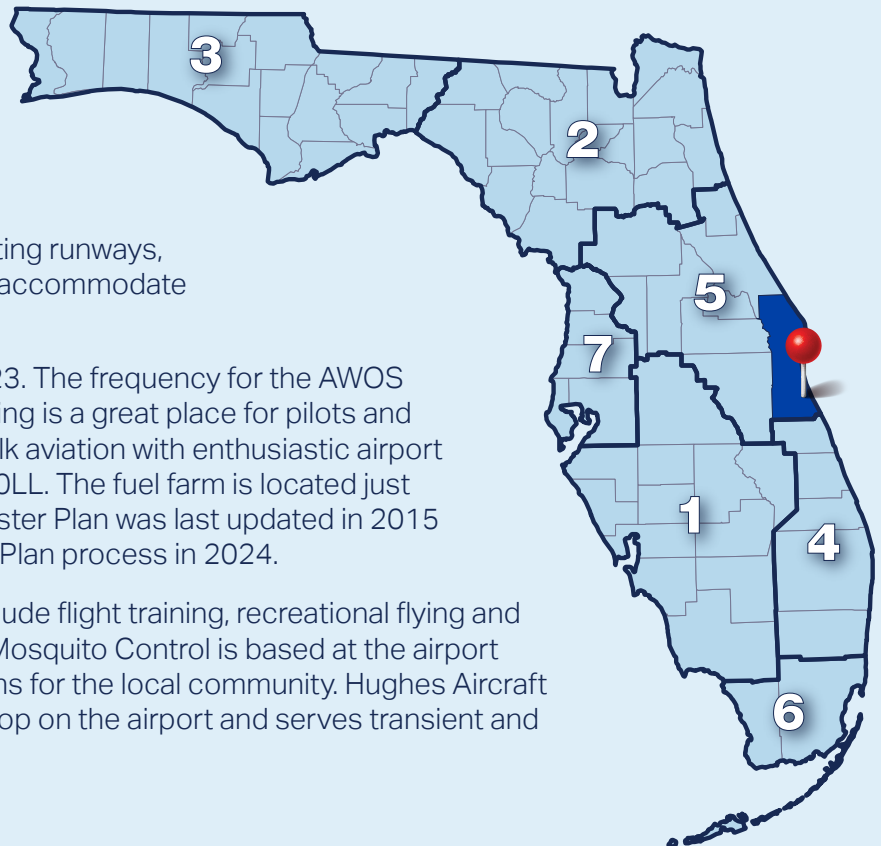

Located in southeastern Brevard County, approximately nine miles south of Melbourne and one-half mile west of the town of Valkaria, Valkaria Airport primarily serves general aviation and the recreational flying needs of Brevard County and the surrounding area. With its two intersecting runways, both which are 4,000 feet long, the airport can accommodate many types of GA and experimental aircraft.

The Airport installed a new Super AWOS in 2023. The frequency for the AWOS is 119.525. Valkaria's new Administration building is a great place for pilots and passengers to unwind, have a cool drink and talk aviation with enthusiastic airport staff. There is a self-serve fuel farm offering 100LL. The fuel farm is located just west of the entrance to Taxiway A. The X59 Master Plan was last updated in 2015 and the Airport expects to begin a new Master Plan process in 2024.

The main activities that occur at the airport include flight training, recreational flying and occasional military exercises. Brevard County Mosquito Control is based at the airport and conducts aerial pesticide control operations for the local community. Hughes Aircraft Services is the aircraft manufacturing repair shop on the airport and serves transient and local users' needs.

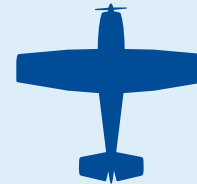

Overview of the FASP 2043 Update:

Per Florida statute, the Florida Aviation System Plan (FASP) is periodically updated to summarize the airport and aviation needs in Florida while remaining consistent with the goals of the Florida Transportation Plan (FTP). The FASP 2043 Update focuses on reviewing the applicability of the various goals, objectives, and performance measures to support two primary goals: 1) provide for more efficiency in decision making within FDOT to support funding and development decisions, and 2) provide airports within the system with recommendations for development that support their individual missions while contributing to the overall strength and health of the Florida airport system.
