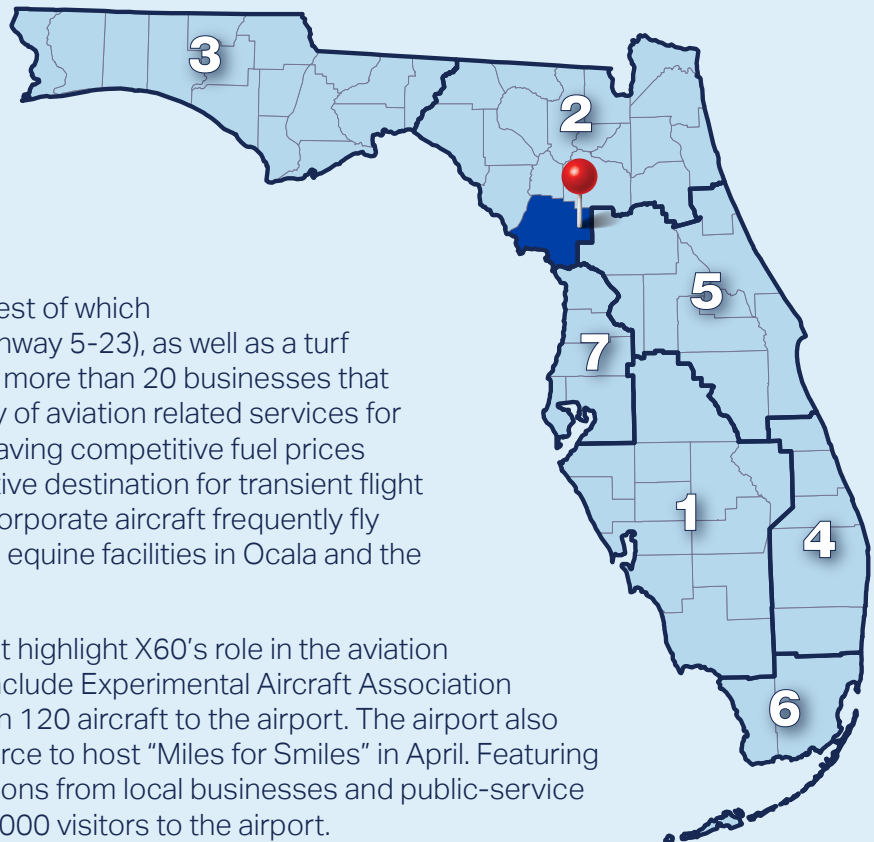

Williston Municipal Airport (X60) is a publicly owned, public-use airport in north-central Florida, located two miles south of Williston. X60 is owned and operated by the City of Williston and serves a variety of general aviation (GA) activities.

The airport offers two paved runways, the longest of which measures 6,669 feet long by 100 feet wide (Runway 5-23), as well as a turf landing facility (Runway 18-36). X60 is home to more than 20 businesses that bolster the local economy and provide a variety of aviation related services for aircraft and pilots. The airport prides itself on having competitive fuel prices and uncongested airspace, making it an attractive destination for transient flight training operations and recreational aviators. Corporate aircraft frequently fly into X60 to bring travelers to several prominent equine facilities in Ocala and the surrounding region.

The airport hosts a variety of annual events that highlight X60's role in the aviation system and local community. Notable events include Experimental Aircraft Association (EAA) Young Eagles events that bring more than 120 aircraft to the airport. The airport also partners with the Williston Chamber of Commerce to host "Miles for Smiles" in April. Featuring static aircraft and car displays and demonstrations from local businesses and public-service entities, this annual event attracts more than 2,000 visitors to the airport.

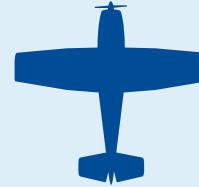

Overview of the FASP 2043 Update:

Per Florida statute, the Florida Aviation System Plan (FASP) is periodically updated to summarize the airport and aviation needs in Florida while remaining consistent with the goals of the Florida Transportation Plan (FTP). The FASP 2043 Update focuses on reviewing the applicability of the various goals, objectives, and performance measures to support two primary goals: 1) provide for more efficiency in decision making within FDOT to support funding and development decisions, and 2) provide airports within the system with recommendations for development that support their individual missions while contributing to the overall strength and health of the Florida airport system.
