Information entered in the consultant tab will populate other fields in the spreadsheet.

Here is how it translates to the Employee Tab:

**Employee Tab- Part 1**

Sort Employees

Consultant firm populates this tab with each employee proposed to provide services on the contract. The employee info must match the information evaluated by the agency during the selection. Local agency uses resumes to verify info as needed. Job classifications proposed must match the scope of services identified in the RFP.

The firm names entered in the consultant tab populate to the employee tab and are listed in the drop down menu

List of job classifications are prepopulated based on FDOT Negotiations Handbook. Consultant must select from drop down menu.

Agency may choose to pay premium overtime. Not required.

If overtime is necessary, a firm is only eligible for premium overtime if the FDOT prequalification letter shows them as "Excluded".

Table 6 provides a summary of all the loaded rates for the contract. This summary is a good option when attaching contract cost information to agency board meeting agendas, etc. because all the confidential cost data is hidden.
