## What We Did

---

The Florida Department of Transportation's (Department) Office of Inspector General (OIG) conducted an audit of the Department's rail inspection program under the management of the Freight and Rail Office (FRO). The purpose of this engagement was to evaluate if rail inspections are being conducted in compliance with federal regulations, state statutes, and Department policies. This audit was conducted as a part of our annual work plan for the fiscal year (FY) 2021-22.

**BACKGROUND AND INTRODUCTION**

---

The Florida Department of Transportation's (Department) Freight and Rail Office (FRO) manages the State Rail Safety Participation Program (Program). The purpose of this Program is to promote safety in all areas of railroad operations to reduce deaths, injuries, and damage to property resulting from railroad accidents. This Program allows the Department to work in partnership with the Federal Railroad Administration (FRA) in performing investigative, surveillance, and enforcement activities under the Federal Railroad Safety Regulations.

Rail safety requirements are outlined through a combination of federal and state laws. Title 49, Part 200-299, Code of Federal Regulations (C.F.R.), includes rules, regulations, and procedures associated with rail inspections. Subsection 341.302(8), Florida Statutes, (F.S.) (2021) directs the Department to "conduct, at a minimum, inspections of track and rolling stock; train signals and related equipment; hazardous materials transportation, including the loading, unloading, and labeling of hazardous materials at shippers', receivers', and transfer points; and train operating practices to determine adherence to state and federal standards."

The Program has five rail safety inspector positions each certified in one of the five rail safety disciplines. Each rail safety inspector becomes certified by FRA to determine compliance with federal regulations, investigate complaints, respond to rail related technical requests, and assist federal agencies in investigating rail incidents. The five rail safety inspector disciplines are as follows:

- **Hazardous Materials (HM) Inspectors** review and observe the procedures used by rail carriers who transport hazardous materials. These HM procedures include classification, packaging, marking, labeling, placarding, loading, and documentation of shipments. In addition, HM inspectors review rail carriers' documentation and procedures for loading, unloading, switching, and transporting rail cars of hazardous materials.
- **Motive Power and Equipment (MP&E) Inspectors** examine the design, construction, condition, maintenance, and operation of locomotives and freight cars (including motive power and related appurtenances). MP&E inspectors also observe brake tests and examine records, including those on-board locomotives and in shops.
- **Operating Practices (OP) Inspectors** review railroad records on accidents/incident reporting, drug and alcohol testing, locomotive engineer certification, operational tests/inspections, hours of service, training programs on operating rules, and radio procedures.

- **Signal and Train Control (S&TC) Inspectors** monitor railroad carrier compliance with regulations and standards concerning signals and train control systems, devices, and appliances. S&TC Inspectors also monitor compliance with inspection, testing, maintenance, and prompt repair of highway-rail grade crossings warning devices. In addition, S&TC Inspectors monitor compliance with requirements for filing block signal applications.
  
- **Track Inspectors** monitor compliance with regulations and standards concerning railroad tracks and related appurtenances. Track Inspectors determine the condition of roadbed, track structure, track geometry, and track-related devices. Track inspectors assist railroads in the review of designs for existing and proposed railway tracks. In addition, Track Inspectors monitor construction, operations, inspections, and repairs to ensure compliance with safety standards and monitor compliance with Bridge Worker Safety Standards.

**RESULTS OF REVIEW**

The objective of this audit was to evaluate if rail inspections are being conducted in compliance with federal regulations, state statutes, and Department policies.

**Finding 1 – Compliance with Federal Regulations, State Statutes, and Department Policies**

**We determined** that rail inspections are being conducted in compliance with federal regulations, state statutes, and Department policies.

The Department is required under Subsection 351.37, F.S. (2021), to “supplement and not replace the responsibility of the Federal Government in the inspection of physical conditions of railroad facilities within the state to ascertain compliance with federal standards and regulations.” We reviewed the Department’s policies and procedures related to the rail safety inspection program and determined that the Department’s documented policies and procedures are adequate to supplement the inspection of railroad facilities.

All Rail Safety Inspectors must be certified inspectors by the FRA or enrolled in an FRA training program leading to certification in one of five rail safety specializations. We reviewed the training records for the four current rail safety inspectors and determined that the required training was completed and in compliance, as shown in Table 1.

We observed two highway-rail grade crossing inspections and determined these rail inspections were being performed in compliance with federal regulations within the S&TC compliance manual issued by the FRA. The inspection areas observed and tested are shown in Table 2.

Employing FRA trained and certified inspectors provides reasonable assurance that inspections are being conducted in compliance with federal regulations. Conducting inspections in compliance with federal regulation promotes safety in all areas of railroad operations to reduce deaths, injuries, and damage to property.
