- 1. I-4 and I-75 interchange -- Hillsborough County Modifying the eastbound and westbound I-4 (Exit 9) ramps onto northbound I-75 into a single entrance point with a long auxiliary lane. (2 miles)
- 2. Polk County -- Reconstructing the State Road 559 (Ex 44) interchange
- 3. Polk County -- Installing Truck Parking Availability System for the eastbound and westbound Rest Areas at mile marker 46.
- 4. Polk County -- Installing a new Fog/Low Visibility Detection System on Interstate 4 from the east end of the Polk Parkway to the Osceola County line
- Orlando metro area -- Adding lanes and reconstruction from Kirkman Road in Orange County (Exit 75B) to east of State Road 434 in Seminole County (21 miles)

Interstate 10

- 6. Escambia County -- Interchange /adding lanes at S.R. 95 (U.S. 29/ Exit 10A/10B) (.7 miles)
- 7. Escambia County -- Adding lanes and reconstructing from east of S.R. 291 (Davis Hwy) (Exit 13) to east of U.S. 90 (Exit 17) (2.7 miles)
- 8. Santa Rosa County -- Adding lanes and reconstructing from the Escambia Bay Bridge to east of S.R. 281(Avalon Boulevard) (Exit 22) (4.1 miles)
- 9. Washington County- Milling and resurfacing from the Choctawhatchee River Bridge, near Exit 104 (County Road 279) to the Washington/Holmes County line (6 miles)
- 10. Jackson County- Milling and resurfacing from East of State Road 71 to County Road 69A (8.7 miles)
- 11. Gadsden County Resurfacing from west of U.S. 90 to the Leon County Line (3 miles)
- Jefferson County -- Renovating eastbound and westbound rest areas at mile marker 233
- 13. Duval County -- Reconstructing the U.S. 301 interchange (Exit 343)
- 14. Duval County -- Reconstructing the State Road 23 (Cecil Commerce Center Parkway) interchange (Exit 350)
- 15. Duval County -- Operational improvements to the interchange at I-95 include providing a dedicated ramp to Irene and Stockton Street, and widening of the overpass from I-95 northbound to I-10 westbound

- 16. Alachua County Resurfacing from State Road 121 (Exit 382) to State Road 222 (Exit 390 (8 miles)
- 17. Sumter County -- Adding lanes from south of County Road 470 to south of the Turnpike (7.6 miles)
- 18. Hernando County Adding lanes and resurfacing from south of State Road 50 to the Sumter County line (6.25 miles)
- 19. Pasco County Adding lanes and resurfacing from north of County Road 54 (Exit 279) to north of State Road 52 (Exit 285) (6.7 miles)
- 20. Hillsborough County Modifying the eastbound and westbound I-4 (Exit 9) ramps onto northbound I-75 into a single entrance point with a long auxiliary lane (2 miles)
- 21. Manatee County -- Interchange improvement project at State Road 64 (Exits 220A and 220B)
- 22. Manatee/Sarasota counties -- Constructing a Diverging Diamond interchange at University Parkway
- 23. Sarasota County Adding lanes and reconstructing the interchange from Fruitville Road (Exit 210) to University Parkway (Exit 213) (3.1 miles)

- 24. Charlotte County Adding lanes and resurfacing from south of N. Jones Loop Road to north of US 17 (4.5 miles)
- 25. Charlotte County Installing Truck Parking Availability System for the northbound and southbound Weigh Stations at mile marker 158
- 26. Lee County -- Replacing 13 Dynamic Message Signs from mile marker 117 to mile marker 145
- 27. Lee County Installing Truck Parking Availability System for the northbound and southbound Rest Areas at mile marker 131
- Collier County -- Replacing 11 Dynamic Message Signs rom mile marker 61 to mile marker 114
- 29. Collier County -- Installing Truck Parking Availability System for the northbound and southbound Rest Areas at mile marker 63
- 30. I-75/Alligator Alley Collier County Building a new Rest Area and water treatment plant on the north side of the roadway (mile marker 63)
- 31. Broward County -- Installing Truck Parking Availability System for Rest Area on Alligator Alley at mile marker 34, 11 miles north of U.S. 27
- 32. Broward County -- Adding four express lanes in the median of I-75 from the I-595/Sawgrass Expressway Interchange (Exit 19) in Weston/Sunrise to one mile south of the Miami-Dade County line, includes a new bridge with direct connection to the I-595 express lanes and new ramps to the Homestead Extension of the Florida's Turnpike (Exit 5) (15 miles)

- 33. Manatee County Constructing new public rest area at the south end of the Sunshine Skyway Bridge (Exit 7)
- 34. Pinellas County Constructing new public rest area at the north end of the Sunshine Skyway Bridge (Exit 13)
- 35. Pinellas County Various maintenance repairs and assessment of future maintenance needs on the Sunshine Skyway, Bunces Pass and Dick Misener bridges (8.2 miles)
- 36. Pinellas County Widening from south of Gandy Boulevard (Exit 28) to 4th Street North (mile marker 32) to add toll lanes next to existing freeway lanes, as part of the Gateway Expressway project. (5 miles)

- 37. Nassau County -- Reconstructing A1A/SR 200 into a Diverging Diamond Interchange (Exit 373)

- 43. Indian River County -- Adding lanes, widening overpasses and modifying Interchange ramps from the Brevard County line south to State Road 60/ Osceola Boulevard (Exit 147) at Vero Beach (12.5 miles)
- 44. St. Lucie County Installing Truck Parking Availability System for northbound and southbound Rest Areas at mile marker 131, two miles north of Orange Avenue/SR 68 (Exit 131) near Fort Pierce
- 45. St. Lucie County Removing and replacing bridge decks over Ten Mile Creek, south of Okeechobee Road (mile marker 129), and over Glades Cut-Off Road/FEC Railroad (mile marker 125) near Fort Pierce

- 46. Martin County Installing Truck Parking Availability System for the south-bound Rest Area at mile marker 107, three miles south of Martin Highway / SR 714 (Exit 110), near Palm City; the northbound Rest Area at mile marker 106, four miles south of Martin Highway /SR 714 (Exit 110) near Palm City; the southbound Weigh-in-Motion Station at mile marker 113, one mile south of Becker Road (Exit 114), near Palm City; and the northbound Weigh-in-Motion Station at mile marker 92, four miles south of Bridge Road (Exit 96), near Hobe Sound
- 47. Martin/Palm Beach County Resurfacing from County Road 708/Bridge Road (Exit 96) near Hobe Sound to State Road 706/Indiantown Road (Exit 87) at Jupiter
- 48. Palm Beach County Improving interchange at Donald Ross Road (Exit 83) in Jupiter; 10th Avenue North (Exit 64) in Lake Worth; Hypoluxo Road (Exit 60) in Lantana and Woolbright Road (Exit 56) in Boynton Beach
- 49. Palm Beach/Broward County Adding a lane and converting the HOV lane in both directions to extend the express lanes from SW 10th Street (Exit 41) in Deerfield Beach to Glades Road (Exit 45) in Boca Raton, widening or replacing bridges, installing ITS and tolling equipment, installing express lane markers (poles), installing ramp metering signals and relocating utilities and landscaping (4 miles)
- 50. Broward County Adding a lane and converting the HOV lane in both directions to extend the express lanes from Broward Boulevard (Exit 27) in Fort Lauderdale to SW 10th Street (Exit 41) in Deerfield Beach, widening bridges, building noise walls in selected locations, installing ITS and tolling equipment, installing express lane markers (poles) and repaving all travel lanes (14 miles)
- 51. Miami-Dade County -- Constructing five emergency stopping sites (three northbound & two southbound) in median from NW 62nd Street to NW 131st Street. The project also includes replacing the concrete driving surface from NW 29th Street to NW 79th Street (6.2 miles)
