LOCAL AGREEMENT

This Local Agreement between Department of Transportation District 2, Structures and Facilities Operations yard or Maintenance Yard, hereinafter referred to as DOT, and the Department of Corrections' Baker Correctional, hereinafter referred to as FDC, shall be an attachment to and made a part of the Master Agreement #W1177 between the above-mentioned agencies dated 25th day of June 2020.

DOT agrees to compensate FDC for inmate labor as provided by this Local Agreement, for maintenance activities listed in the Master Agreement Addendum "B" (attached). The estimated amount of annual compensation of \$323,293.50 as provided for by this Local Agreement for the following activities:

DOT agrees to supervise 15 community and/or minimum custody inmates as supplemental support labor.

FDC agrees to provide 1 correctional officer to supervise 5 inmates for labor to be performed as scheduled by DOT.

The workweek shall be as follows:

Monday thru Thursday. Typically, the Correctional Officer and inmates shall make every attempt to report directly to the site scheduled for the day. When work situations require reporting directly to the designated maintenance facility, i.e. Lake City Bridge Maintenance Facility or Jacksonville Bridge Maintenance Facility, they shall report at 7:00am and depart at 5:00pm.

DOT shall compensate FDC for the above-mentioned number of inmates at the wage rate in Addendum "B" of this Agreement per inmate hour for each work day when that number is made available by FDC, whether used or not as supplemental/support labor by DOT. If a lesser number than that stated above is made available, compensation shall be for the number made available. If DOT agrees to supervise additional inmates that exceeds the above-mentioned number,

compensation shall be for the number stated above plus those in addition to that number.

Other provisions of this agreement are as follows:

FDC shall provide notice to DOT within one (1) hour of work shift start time should an FDC Officer not be available to supervise assigned inmates on a scheduled work day.

FDC shall notify DOT in the event FDC cannot fulfill the obligations as described in this Local Agreement.

The effective dates of this agreement are July 1, 2020, through June 30, 2021. Provisions of this Local Agreement may be amended by written agreement of the parties. This Local Agreement may add to and/or expand upon the provisions of the Master Agreement, but shall not modify the intent of the provisions contained herein.
