LOCAL AGREEMENT

This Local Agreement between Department of Transportation District 2, Structures and Facilities Operations yard or Maintenance Yard, hereinafter referred to as DOT, and the Department of Corrections' Columbia Correctional, hereinafter referred to as FDC, shall be an attachment to and made a part of the Master Agreement between the above-mentioned agencies dated 29th day of June, 2017

DOT agrees to compensate FDC for inmate labor up to the amount of \$107,764.50 as provided for by this Local Agreement for the following activities:

Using Activity 036 in Addendum "B", DOT agrees to compensate FDC for daily FDC Officer Travel Time between the Department of Corrections facility and the work site, except as limited below:

- If FDC Officer Travel Time is less than 30 minutes for a day, no compensation will be provided
- If FDC Officer Travel Time is greater than 2 hours for a day, only 2 hours of compensation will be provided.

DOT agrees to supervise 5 community and/or minimum custody inmates as supplemental support labor. DOT shall compensate FDC for the above-mentioned number of inmates at the wage rate in Addendum "B" of this Agreement per inmate hour for each work day when that number is made available by FDC, whether used or not as supplemental/support labor by DOT. If a lesser number than that stated above is made available, compensation shall be for the number made available. If DOT agrees to supervise a number of inmates that exceeds the above-mentioned number, compensation shall be for the number stated above plus those in excess of that number.

FDC agrees to provide 1 correctional officer to supervise 5 inmates for labor to be performed as scheduled by DOT. DOT shall compensate FDC for each unit of work satisfactorily completed at the cost per unit as specified above.

The workweek shall be as follows:

Tuesday through Friday. Typically, the Correctional Officer and inmates shall make every attempt to report directly to the site scheduled for the day. When work situations require reporting directly to the designated maintenance facility, i.e. Lake City Bridge Maintenance Facility or Jacksonville Bridge Maintenance Facility, they shall report at 7:00am and depart at 5:00pm.

Other provisions of this agreement are as follows:

All work shall be performed in accordance with each specific maintenance activity performance standard and in accordance with the Memorandum of Agreement between the FDC and the DOT for the 2017-2018 fiscal year.

The effective dates of this agreement are July 1, 2017, through June 30, 2018. Provisions of this Local Agreement may be amended by written agreement of the parties. This Local Agreement may add to and/or expand upon the provisions of the Master Agreement, but shall not modify the intent of the provisions contained herein.
