

ADDENDUM "A"

CONTRACT BE797

LOCAL AGREEMENT (FY 19/20)

This Local Agreement between Department of Transportation, District 3, Milton Operations, hereinafter referred to as DOT, and the Department of Corrections' Santa Rosa Prison Work Camp, hereinafter referred to as FDC, shall be made a part of the Master Agreement between the above-mentioned agencies dated 26th day of June 2019.

DOT agrees to compensate FDC for inmate labor, as provided for by this Local Agreement, for maintenance activities listed in the Master Agreement Addendum "B" (attached). The estimated amount of annual compensation for this Local Agreement is \$470,000.00.

DOT agrees to supervise 0 community and/or minimum custody inmates as supplemental support labor.

FDC agrees to provide four (4) correctional officers to supervise twenty (20) inmates for labor to be performed as scheduled by DOT.

The workweek shall be as follows:

Monday 6:30 a.m. – 5:00 p.m. – two (2) D.C. Crews with each crew having five (5) inmates and none (0) supplemental support.

Tuesday through Thursday, 6:30 a.m. – 5:00 p.m., four (4) D.C. Crews with each crew having five (5) inmates and none (0) supplemental support.

Friday 6:30 a.m. – 5:00 p.m. – two (2) D.C. Crews with each crew having five (5) inmates and none (0) supplemental support.

The Department of Transportation, District 3, Milton Operations and the Department of Corrections' Santa Rosa Prison Work Camp mutually agree to schedule and provide correctional officers and inmate crews in excess of the number of officers and inmate crews scheduled per week, as specified in the Local Agreement. Work crews in excess of the number of work crews specified in the Local Agreement will be for the purpose of performing DOT identified work needs; payment will be at the regular hourly rate for inmates and travel time for officers (if needed). Overtime rates will not apply to the temporary additional work crews described herein.

Other provisions of this Local Agreement are as follows:

FDC shall provide notice to DOT within one (1) hour of work shift start time should an FDC Officer not be available to supervise assigned inmates on a scheduled work day.

FDC shall notify DOT in the event FDC cannot fulfill the obligations as described in this Local Agreement.

The effective dates of this Agreement are July 1, 2019, through June 30, 2020. Provisions of this Local Agreement may be amended by written agreement of the parties.
