
### **Q1 Overall Maintenance Conference Rating**



### **Q2 Usefulness of Information Received**



#### Q3 Applicability of Program Content to Onthe-Job Effectiveness



### Q4 Allocation of Program Time to Each Subject Area



### **Q5 Meeting Facilities**



## Q6 How often do you think the Office of Maintenance should host the FDOT Maintenance Conference?


