**LOCAL AGREEMENT**

This Local Agreement between Department of Transportation, District Two, Perry Maintenance Yard, hereinafter referred to as DOT, and the Department of Corrections' Taylor Correctional Institute, hereinafter referred to as FDC, shall be an attachment to and made a part of the Master Agreement between the above-mentioned agencies dated 25th day of June, 2017.

**DOT agrees to compensate FDC for inmate labor the estimated amount of \$386,382.00 as provided for by this Local Agreement for the following activities:**

DOT agrees to supervise N/A community and/or minimum custody inmates as supplemental support labor.

FDC agrees to provide four (4) correctional officers to supervise twenty (20) inmates for labor to be performed as scheduled by DOT.

The workweek shall be as follows:

The work crews will report to the Perry Maintenance Yard Monday through Thursday at 7:00 a.m. and depart the Perry Maintenance Yard at 5:00 p.m. to return to the work camp. Each work crew will work a total of 9.5 hours per day with a thirty minute lunch period.

Other provisions of this Local Agreement are as follows:

The FDC Officer shall have the authority to decide when to return to the Institute during inclement weather.

Crews shall not report on the following state holidays: New Year's Day, Martin Luther King Day, Memorial Day, Independence Day, Labor Day, Monday after Veteran's Day (observed on Monday, November 13<sup>th</sup>), Thanksgiving Day, and Christmas Day.

The effective dates of this Agreement are July 1, 2017, through June 30, 2018. Provisions of this Local Agreement may be amended by written agreement of the parties.
