ADDENDUM A

LOCAL AGREEMENT

This Local Agreement between the Department of Transportation, District 5, **Oviedo Operations**, hereinafter referred to as **DOT**, and the Department of Corrections' **Central Florida Reception Center**, hereinafter referred to as **FDC**, shall be an attachment to and made a part of the Master Agreement between the above-mentioned agencies dated 25th day of June 2017.

DOT agrees to compensate FDC for inmate labor up to the amount of \$799,000.00 as provided for by this Local Agreement for the following activities:

<u>Using Activity 036 in Addendum "B", DOT agrees to compensate FDC for daily FDC Officer Travel Time between</u> the Department of Corrections facility and the work site, except as limited below:

- If FDC Officer Travel Time is less than 30 minutes for a day, no compensation will be provided.
- If FDC Officer Travel Time is greater than 2 hours for a day, only 2 hours of compensation will be provided.

DOT agrees to supervise <u>4</u> community and/or minimum custody inmates as supplemental support labor. DOT shall compensate FDC for the above-mentioned number of inmates at the production wage rate in Addendum B of this Agreement per inmate hour for each work day when that number is made available by FDC, whether used or not, as supplemental/support labor by DOT. If a lesser number than that stated above is made available, compensation shall be for the number made available. If DOT agrees to supervise a number of inmates that exceeds the above-mentioned number, compensation shall be for the number stated above plus those in excess of that number.

FDC agrees to provide ___6_ correctional officers to supervise __30__ inmates for labor to be performed as scheduled by DOT. The DOT shall compensate FDC for each unit of work satisfactorily completed at the cost per unit as specified above.

The workweek shall be as follows:

Four (4) crews shall work Monday through Friday, five (5) seven and one-half (7-1/2) hour workdays, 7:00 A.M. to 3:00 P.M. with one-half (1/2) hour for lunch. Travel Time will be provided at one (1) hour per officer per day. Two (2) crews shall work Monday through Friday, four (4) nine and one-half (9-1/2) hour work days, 6:00 A.M. to 4:00 P.M. with one-half (1/2) hour for lunch. Travel Time will be provided at one and one-half (1-1/2) hours per officer per day.

The Master Agreement as agreed to annually between the DOC and the FDC is incorporated into Asset Maintenance Contract E-5P62. The Master Agreement will govern in any discrepancies between the Asset Maintenance Contract and the Master Agreement.

DOT will provide one (1) inmate crew from Oviedo Maintenance to the Asset Maintenance Contractor for performance of routine maintenance activities under Contract E-5P62 as directed by the Asset Maintenance Contractor. The inmate crew will consist of one (1) FDC Officer and five (5) inmates. Work for the inmate crew will be governed by the applicable addendum to the Master Agreement (i.e. Local Agreement) between DOT and FDC.

The Asset Maintenance Contractor will provide, maintain and store all vehicles, equipment and materials necessary for FDC crews assigned work under Contract E-5P62.

DOT will act as liaison between the Asset Maintenance Contractor and FDC. In the event of a dispute, the Asset Maintenance Contractor shall provide documentation to DOT in cases where FDC supervisors fail to follow rules, regulations, policies and procedures pertaining to the performance of assigned work. Decisions by DOT will be considered final resolution to all discrepancies.

The effective dates of this Agreement are July 1, 2017, through June 30, 2018. Provisions of this Local Agreement may be amended by written agreement of the parties. This Local Agreement may add to and/or expand upon the provisions of the Master Agreement, but shall not modify the intent of the provisions contained therein.

The Master Agreement as agreed to annually between the DOC and the FDC is incorporated into Performance Aesthetics Contract E-5Q87. The Master Agreement will govern in any discrepancies between the Performance Aesthetics Contract and the Master Agreement.

DOT will provide one (1) inmate crew from Oviedo Maintenance to the Performance Aesthetics Contractor for performance of routine maintenance activities under Contract E-5Q87 as directed by the Performance Aesthetics Contractor. The inmate crew will consist of one (1) FDC Officer and five (5) inmates. Work for the inmate crew will be governed by the applicable addendum to the Master Agreement (i.e. Local Agreement) between DOT and FDC.

The Performance Aesthetics Contractor will provide, maintain and store all vehicles, equipment and materials necessary for FDC crews assigned work under Contract E-5Q87.

DOT will act as liaison between the Performance Aesthetics Contractor and FDC. In the event of a dispute, the Performance Aesthetics Contractor shall provide documentation to DOT in cases where FDC supervisors fail to follow rules, regulations, policies and procedures pertaining to the performance of assigned work. Decisions by DOT will be considered final resolution to all discrepancies.

The effective dates of this Agreement are July 1, 2017, through June 30, 2018. Provisions of this Local Agreement may be amended by written agreement of the parties. This Local Agreement may add to and/or expand upon the provisions of the Master Agreement, but shall not modify the intent of the provisions contained therein.
