

# STATE OF FLORIDA

## OFFICE OF THE GOVERNOR EXECUTIVE ORDER NUMBER 19-33 (Emergency Management – Extension of Executive Order 18-276)

**WHEREAS**, on October 10, 2018, Hurricane Michael became a high-end Category 4 Hurricane prior to its landfall; and

**WHEREAS**, on October 10, 2018, Hurricane Michael made landfall near Mexico Beach, Florida, as a high-end Category 4 Hurricane, ranking by pressure as the third-most intense Atlantic hurricane to ever make landfall in the United States; and

**WHEREAS**, the impact of Hurricane Michael was felt throughout the Panhandle; and

**WHEREAS**, on October 7, 2018, Governor Rick Scott issued Executive Order 18-276 declaring a state of emergency for twenty-six counties throughout the Florida Panhandle due to the forecasted strength and projected path of Hurricane Michael; and

**WHEREAS**, on October 8, 2018, Governor Rick Scott issued Executive Order 18-277 declaring a state of emergency in nine additional counties; and

**WHEREAS**, I, as Governor of the State of Florida, have taken multiple trips to the Panhandle to see the recovery efforts and the grave need for more resources; and

**WHEREAS**, I, as Governor of the State of Florida, am committed to providing every available resource for our residents, businesses and communities in the Panhandle as we recover and rebuild; and

**WHEREAS**, no state of emergency declared pursuant to the Florida Emergency Management Act may continue for more than 60 days unless renewed by the Governor; and

**WHEREAS**, the State of Florida remains committed to helping every family recover from this devastating storm; and

**WHEREAS**, the following counties are still recovering from the catastrophic storm surge and flooding, and historic damage caused by Hurricane Michael: Okaloosa, Walton, Holmes, Washington, Bay, Jackson, Calhoun, Gulf, Gadsden, Liberty, Franklin, Leon, Wakulla and Jefferson; and

**WHEREAS**, the effects of Hurricane Michael pose a continuing threat to the health, safety and welfare of the State of Florida and its residents.

**NOW, THEREFORE, I, RON DESANTIS**, as Governor of Florida, by virtue of the authority vested in me by Article IV, Section 1(a) of the Florida Constitution and by the Florida Emergency Management Act, as amended, and all other applicable laws, promulgate the following Executive Order, to take immediate effect:

Section 1. The state of emergency declared in Executive Order 18-276 and amended by Executive Order 18-277, and extended by Executive Order 18-360 will be extended for 60 days following the issuance of this order, amended to include only the following counties: Okaloosa, Walton, Holmes, Washington, Bay, Jackson, Calhoun, Gulf, Gadsden, Liberty, Franklin, Leon, Wakulla and Jefferson.

Section 2. All actions taken by the Director of the Division of Emergency Management as the State Coordinating Officer with respect to this emergency before the issuance of this Executive Order are ratified, and he is directed to continue to execute the State's Comprehensive Emergency Management Plan and other response, recovery, and mitigation plans necessary to cope with the emergency.

Section 3. Except as amended herein, Executive Orders 18-276, 18-277 and 18-360

are ratified and reaffirmed.
