## Chapter 1 – Facility Profile Manager (Company Role) Notification Recipient

Whenever users in company roles are assigned as recipients, MAC evaluates the record that triggered the notification for a company relationship. It uses this to determine the appropriate people to notify. These notifications are designated with a # by the Will Receive Notification symbol. When you see a ✓#, you know that you are set up as a recipient based on a company role.

All these notifications are set so that you Can Opt Out. This means you will get them unless you opt out. If you don't want them, opt out. Be careful opting out if you are the only user with that role for the company, particularly lab managers and facility profile managers.

If you want the notifications, you don't need to apply any filters. It is normally not good to filter on a notification with the checkmark and pound sign. It's too easy to create a conflict and filtering does not overwrite the internal filtering done by MAC.

## Chapter 2 – Aggregate Production Facilities

The notifications in this section are triggered by a PMU updating the production facility or product status. Aggregate production facilities have Producer Quality Control Plans and those plans have a status, but the production facilities have an overall status independent of the PQCP.

Because Facility Profile Manager is a company role and there is a Facility Profile Manager on the profile, MAC programming knows which Profile Manager to notify without needing a subscription or filters.

### A. Production Facility Profile

#### ***Production Facility has been created***

This is triggered when the DMRO or SMO QC Program Maintenance User creates a production facility profile. MAC notifies the production facility profile manager on the profile.

#### ***Production Facility has been approved***

This is triggered when the DMRO or SMO QC Program Maintenance User changes the production facility status to approved. MAC notifies the production facility profile manager on the profile.

#### ***Production Facility has been expired***

This is triggered when the DMRO or SMO QC Program Maintenance User changes the production facility status to expired. MAC notifies the production facility profile manager on the profile.

#### ***Production Facility has been inactivated***

This is triggered when the DMRO or SMO QC Program Maintenance User changes the production facility status to inactive. MAC notifies the production facility profile manager on the profile.

#### ***Production Facility has been revoked***

This is triggered when the DMRO or SMO QC Program Maintenance User changes the production facility status to revoked. MAC notifies the production facility profile manager on the profile.

#### ***Production Facility has been suspended***

This is triggered when the DMRO or SMO QC Program Maintenance User changes the production facility status to suspended. MAC notifies the production facility profile manager on the profile.

***Production Facility has been updated***

This is triggered when the DMRO or SMO QC Program Maintenance User makes changes to the production facility profile. MAC notifies the production facility profile manager on the profile.

***Production Facility has been closed date has changed***

This is triggered when the DMRO or SMO QC Program Maintenance User changes the existing closed date on the production facility profile. MAC notifies the production facility profile manager on the profile.

B. Products

***Product Status Changed***

This is triggered when the DMRO or SMO QC Program Maintenance User changes a product status. MAC notifies the production facility profile manager on the profile.

## Chapter 3 – Nonstructural Concrete Production Facilities

The notifications in this section are triggered by a PMU updating the production facility status. Nonstructural concrete production facilities do not have a Producer Quality Control Plan.

Because Facility Profile Manager is a company role and there is Facility Profile Manager on the profile, MAC programming knows which Profile Manager to notify without needing a subscription or filters.

### A. Production Facility Profile

#### ***Production Facility has been created***

This is triggered when the DMRO or SMO QC Program Maintenance User creates a production facility profile. MAC notifies the production facility profile manager on the profile.

#### ***Production Facility has been approved***

This is triggered when the DMRO or SMO QC Program Maintenance User changes the production facility status to approved. MAC notifies the production facility profile manager on the profile.

#### ***Production Facility has been expired***

This is triggered when the DMRO or SMO QC Program Maintenance User changes the production facility status to expired. MAC notifies the production facility profile manager on the profile.

#### ***Production Facility has been inactivated***

This is triggered when the DMRO or SMO QC Program Maintenance User changes the production facility status to inactive. MAC notifies the production facility profile manager on the profile.

#### ***Production Facility has been revoked***

This is triggered when the DMRO or SMO QC Program Maintenance User changes the production facility status to revoked. MAC notifies the production facility profile manager on the profile.

#### ***Production Facility has been suspended***

This is triggered when the DMRO or SMO QC Program Maintenance User changes the production facility status to suspended. MAC notifies the production facility profile manager on the profile.

***Production Facility has been updated***

This is triggered when the DMRO or SMO QC Program Maintenance User makes changes to the production facility profile. MAC notifies the production facility profile manager on the profile.

***Production Facility has been closed date has changed***

This is triggered when the DMRO or SMO QC Program Maintenance User changes the existing closed date on the production facility profile. MAC notifies the production facility profile manager on the profile.

## Chapter 4 – Production Facilities other than Aggregate or Nonstructural Concrete

The notifications in this section are triggered by a PMU updating the Producer QC Plan or product status.

Because Facility Profile Manager is a company role and there is Facility Profile Manager on the profile, MAC programming knows which Profile Manager to notify without needing a subscription or filters

### A. Producer QC Plan

#### ***Production Facility QC Plan has been approved***

This is triggered when the DMRO or SMO QC Program Maintenance User changes the production facility Producer QC Plan status to approved. MAC notifies the production facility profile manager on the profile.

#### ***Production Facility QC Plan has been expired***

This is triggered when the DMRO or SMO QC Program Maintenance User changes the production facility Producer QC Plan status to expired. MAC notifies the production facility profile manager on the profile.

#### ***Production Facility QC Plan has been suspended***

This is triggered when the DMRO or SMO QC Program Maintenance User changes the production facility Producer QC Plan status to suspended. MAC notifies the production facility profile manager on the profile.

#### ***Production Facility QC Plan has been inactivated***

This is triggered when the DMRO or SMO QC Program Maintenance User changes the production facility Producer QC Plan status to inactive. MAC notifies the production facility profile manager on the profile.

### B. Products

#### ***Product Status Changed***

This is triggered when the DMRO or SMO QC Program Coordinator changes a product status. MAC notifies the production facility profile manager on the profile.
