Chapter 1 – DMO Asphalt / DMO Concrete

These notifications are intended for users with the mix design roles of DMO Asphalt or DMO Concrete.

Mix Design has Expired

This is triggered when MAC expires a mix design based on the expiration date.

Mix Design Will be Deleted Soon

This notification lets users know when a mix design that is In Progress is about to be deleted due to inactivity. In progress mix designs that were created, but are not updated or submitted after 30 days are deleted from MAC.

Additional Mix Design Info Requested

This is triggered when the DMRO or SMO returns a submitted mix design for additional information. DMO Asphalt and DMO Concrete can opt in if they want to know when the mix design is returned by SMO.

Mix Design Submitted for DMO Review

DMO Asphalt and DMO Concrete will want to subscribe to this notification triggered when a mix design is submitted for DMO review.

Mix Design Submitted for SMO Review

DMO Asphalt and DMO Concrete sometimes trigger this notification and sometimes it is triggered by the Mix Design Submitter or Reviewer when a mix design skips the DMO review.

Mix Design has been Accepted

This notification gets triggered by the DMRO or SMO accepting a mix design

Mix Design has been Rejected

This notification gets triggered by the DMRO or SMO rejecting a mix design.

Mix Design's Product not Approved

This notification is triggered when a DMRO or SMO user changes the status from approved to any other status on a production facility (thereby changing the status on all the products) or changes the product status that is used as a component on a mix design. DMO Asphalt and DMO Concrete will want to subscribe to this notification to determine what action needs to be taken on each mix design.

Chapter 2 – SMO Asphalt / SMO Concrete

These notifications are intended for users with the mix design roles of SMO Asphalt or SMO Concrete. Filters should be selected as follows:

This notification lets users know when a mix design that is In Progress is about to be deleted due to inactivity. In progress mix designs that were created, but are not updated or submitted after 30 days are deleted from MAC.

Additional Mix Design Info Requested

This is triggered when the DMRO or SMO returns a submitted mix design for additional information. SMO Asphalt and SMO Concrete can opt in if they want to know when the mix design is returned by SMO.

Mix Design Submitted for DMO Review

This notification is triggered when a mix design is submitted for DMO review. SMO Asphalt and SMO Concrete are not assigned to this notification.

Mix Design Submitted for SMO Review

SMO Asphalt and SMO Concrete will want to subscribe to this notification. It is sometimes triggered by DMO submitting the mix and sometimes it is triggered by the Mix Design Submitter or Reviewer when a mix design skips the DMO review.

Mix Design has been Accepted

This notification gets triggered by the DMRO or SMO accepting a mix design. SMO Asphalt and SMO Concrete can elect to receive the notification because it is sometimes triggered by a DMRO user.

Mix Design has been Rejected

This notification gets triggered by the DMRO or SMO rejecting a mix design. SMO Asphalt and SMO Concrete can elect to receive the notification because it is sometimes triggered by a DMRO user.

Mix Design's Product not Approved

This notification is triggered when a DMRO or SMO user changes the status from approved to any other status on a production facility (thereby changing the status on all the products) or changes the product status that is used as a component on a mix design. DMO Asphalt and DMO Concrete will want to subscribe to this notification to determine what action needs to be taken on each mix design.
