Introduction

What are the Project Administrator's responsibilities for Materials Certification Review (MC Review)?

The Project Administrator (PA) is the person in responsible charge of the material method of acceptance (MOA) on a contract. The State Construction Office (SCO) has defined the person who can be given the role of PA in MAC. Allowable delegates are defined as the Contract Specialist or the Lead Inspector. In some cases, the Asphalt Plant Technician or Resident Asphalt Specialist can be given the PA role in MAC for asphalt plant samples. The Lead Earthwork VT technician for the Earthwork Records System (ERS) PA functions can be a delegate for the PA role for ERS sample functions.

These instructions describe how to address MC Review findings for the PA role and other functions related to the MC Review including processing the findings through the Materials Acceptance Resolution (MAR) process. Separate instructions are also available for the other users with functions in this process, such as the MC Review Program Maintenance User who will be referred to in this document as the MC Reviewer. Some of the MC Reviewers functions are described in this document because the PA may have follow-up functions to perform.

<u>Materials Manual 5.4 Volume I</u> (*MM 5.4 V1*) governs the process for the review. These instructions are intended to describe the MAC functions for the *MM 5.4 V1* processes. It is not intended to replace the program requirements. If there is a conflict between these instructions and *MM 5.4 V1*, the Materials Manual instructions supersede the instructions in this document.

The Construction Project Administration Manual (CPAM) <u>Section 5.8 Control of Materials</u> and <u>Section 11.5 - Testing and Correcting Asphalt Pavement Surface Deficiencies</u> describes the PA's responsibilities for material requirements.

What is MAR?

Materials Acceptance Resolution (MAR) is the process for documenting the disposition of MOA issues. MOA includes more than just failing material. It includes any material that does not meet requirements such as minimum frequency, qualified personnel, qualified labs and if the QC or Aggregate Control Program material was not produced under program requirements. Any material not meeting the requirements will have to be processed through MAR. Not all MAR issues require recommendations and resolutions by the District Materials and Research Engineer (DMRE), District Construction Engineer (DCE) or Director, Office of Construction (DOC).

What is a finding?

A finding is a potential issue with the MOA. A finding may or may not result in an Exception to the Project Materials Certification Letter (PMCL). Findings can be generated by the system or they can be added manually by PAs or MC Reviewers (PMUs).

What is an issue?

An issue is a finding that needs further action. It is any finding that is not Excluded or MC Resolved. It may result in an Exception. All issues must be promoted to MAR. Not all issues promoted to MAR will result in an Exception.

What is an Exception?

An Exception is a materials issue that meets the definition of a PMCL Exception per *MM 5.4 V1*. All Exceptions must be promoted to MAR in order to have the ability to create the Exception on the PMCL

Chapter 1 – Initiating an MC Review by the MC Reviewer

The MC Review is initiated for each project on a contract by an MC Reviewer. The MC Review should be created as soon as the District Materials and Research Office (DMRO) is notified that the contract has begun. This will allow for automatic findings to be displayed on the findings screen. The PA should notify the MC Reviewer if the MC Review has not yet been initiated.

When the MC Review is created, if there are any existing samples for the contract, the system will populate the automatic findings.

NOTE: PAs may also have company roles. You must be in your system role of PA for the MC Review menu options and functions to appear.



1. Select the Materials Certifications/MAR menu option.

2. Select the Materials Certifications/MAR submenu option.

3. Use the Search option or Go To Material Certification/MAR option to navigate to the MC Review screen.

When an MC Review is initiated, it is checked out the MC Reviewer who created it. During this status, no other MC Reviewer can make modifications to the review. Check in and check out does not apply to the PA. The PA does not need to check out an MC Review in order to work on the findings.

Chapter 3 – Managing Findings

Some findings are generated by the system based on criteria such as a failing test, a required test not being performed, an unqualified technician, etc. Samples can have multiple findings. Similar findings can be related to each other.

A. Findings List on an MC Review

When the MC Review is created or when it is checked out, the system will populate or recalculate the automatic findings. The PA cannot recalculate the findings. If MC Review findings appear on samples but do not appear on the findings list, check the excluded findings to ensure the MC Reviewer has not already excluded the finding. If they are not there, ask the MC Reviewer to recalculate the MC Review.

2. Select the Return to List option to return to the findings list.

B. Findings Statuses

Findings statuses are as follows:

1. **Excluded** – the MC Reviewer has determined that the finding is not an issue. It does not have to be responded to by the PA.

2. **MC Resolved** – the MC Reviewer has determined without the PA's response or is satisfied with the PA's response that the finding is not an issue.

3. **Promoted to MAR** – the finding has a response from the PA and the MC Reviewer and PA agree that the finding should be processed as a MAR issue.

4. MAR Resolved – the finding has made it to the end of MAR process and has a final resolution.

a. **MAR Resolved [Reason for no Follow Up Sample]** – when the finding is a surface tolerance deficiency and the PA designates that no follow-up sample was performed, the status is MAR Resolved with the reason the PA provided for there being no follow-up sample within the brackets.

b. **MAR Resolved & Follow Up Sample hotlink** – when the finding is a surface tolerance deficiency and the PA designates the follow-up sample, the status is MAR Resolved with a hotlink to the follow-up sample.

5. Open – The MC Review submitted a manual to the PA for response or excluded it.

6. **Responded** – The PA has submitted a response to the MC Reviewer.

7. **Returned for Response Clarification** – the MC Reviewer has returned a responded finding to the PA for additional response.

8. **Submitted** – the MC Reviewer has submitted the finding to the PA for a response.

9. **Waiting For Follow Up Sample** – when a surface tolerance deficiency has a final recommendation of Remove and Replace, the status is Waiting For Follow Up Sample until the PA designates the follow-up sample or that a follow-up sample was not performed.

NOTE: The findings statuses can be used as filters to shorten the list that is displayed. Deselecting an option does not remove the findings. It just takes them off the view.

C. Manual Findings

Because not all issues that are possible Exceptions can be detected by the system, there is a way to add a manual finding. These can be created by MC Reviewers or PAs. To create a manual finding:



1. Select the Add Manual Finding option.

2. Finding Type – select the finding type from the dropdown.

NOTE: Selecting the ERS finding type will put the finding under the ERS findings tab.

3. **Description** – enter a *brief* description of the issue. No more than two sentences. You will have the opportunity to add a response and other details on the findings detail screen.

4. **Comparison Package** – if the manual finding is for a specific comparison package, select it from the dropdown.

5. **Sample** – if the manual finding is for a specific sample, select it from the dropdown. the finding/issue.

6. Select the Create option to create the manual finding.

NOTE: **DO NOT** create a Manual finding for materials that can be resolved by delineating (like asphalt). This automatic finding have its own special programming that is triggered from an automatic finding. Creating a manual finding will not allow for the special programming to be triggered and the manual finding will not be able to be processed correctly.

D. Submitting an Open Manual Finding for PA Response (MC Reviewer)

All manual findings start with an Open status. This gives the MC Reviewer the opportunity to review the finding before processing further. If the MC Reviewer agrees the finding is an MC Review issue, they can submit the finding for the PA to respond

4. **Response Text** – enter the description of the finding. The information should include any additional details for the MC Reviewer to assist with determining if the finding is a potential exception. The needed information will depend on the finding itself.

5. Select the Create option.

The finding is still in Submitted status. MAC does not know if you saved the response for now and will update it more or if it's ready to be submitted. You must indicate that the response is ready to be submitted.

If after the MC Reviewer and the PA determine that the finding needs no further action, the finding can be designated with the status of MC Resolved. Similar to excluded findings, MC Resolved findings cannot be promoted to MAR and cannot have an Exception created from the finding. MC Resolved means that after review and comment by the PA and MC Reviewer, the finding does not warrant additional action.

NOTE: Most MC Reviewers will use the Excluded option in lieu of MC Resolving because when Excluding a finding, they are prompted to provide a comment or reason. MC Resolving a finding does not allow for comments.

H. Relating a Finding to other Findings (MC Reviewer)

Often times, findings will be similar in nature and will be resolved with the same disposition. The MC Reviewer can connect findings together by relating them to each other.

The finding details will be updated to show the related findings.

K. Undoing a MAR Promotion (MC Reviewer)

If an item is inadverently sent to MAR, or if one of the users in the MAR process selects the incorrect recommendation or resolution, the MC Reviewer can undo the process.

At this time, MAC cannot roll the finding status back one step, for example if the DCE selects the wrong reccommendation, MAC cannot back it up the DMRE's recommendation. Undoing a MAR takes the finding status all the way back to the Submitted status and you start over. The PA will need to resubmit the responses. All users will need to reperform the steps up to the action that required the MAR promotion to be undone.

Chapter 4 – Processing an Issue through MAR

The PA is responsible for coordinating the steps of the MAR issue through to final resolution. These instructions will describe the process for issues that may require an EAR or delineation. They follow the requirements of *Construction Project Administration Manual (CPAM) Section 5.8*.

Asphalt pavement surface deficiencies have a different MAR process with different users. They are processed according to **CPAM Section 11.5**. <u>Chapter 5 – Processing a MAR Issue for</u> <u>Straightedge Deficiencies</u> describes the process for asphalt pavement surface deficiencies.

A. Making an Initial Recommendation from the Finding Details

When an issue is Promoted to MAR, the first step is for the PA to enter an initial recommendation. There are two ways to get to the functions. This section describes how to make the initial recommendation from the findings details. By doing this, the PA has the option to review the information, comments and documents associated with the finding. Section <u>D. Making an Initial Recommendation from the Findings List</u> describes how to make the finding recommendation from the findings list. Because additional steps and review are usually needed, this is the preferred method.

a. Asphalt Follow up Sample Passed – if the follow up sample as described in *Materials Manual* Section 3.1 V1.

b. **Complete Removal and Replacement** – the material that the finding represents has been removed and replaced before the Contractor requested an EAR to leave in place. If the Contractor voluntarily removes and replaces immediately, this option should be selected.

c. **EAR** – the material meets the definition of defective material and the Contractor has requested the material be left in place and an EAR performed. The PA's recommendation is to allow the Contractor to perform an EAR.

d. **Materials Rejected for Use** – The material has been tested before placement, like a stockpile, and the material was not placed.

e. No Action Required per Materials Manual 3.1 – this ONLY applies when the Department is determining to allow delineation for asphalt failures, the Air Voids are high and the results from QC and IV cores are > 6.0% and <= 7.5% as described in *Materials Manual Section 3.1 V1*.

NOTE: This option **only** applies to this specific finding. **Do not** select it for any other asphalt related findings. **Do not** select it for findings under any other material.

f. **No EAR** – the material meets the definition of defective material and the Contractor has requested the material be left in place and an EAR performed. The PA recommends that the Contractor not be allowed to perform and EAR or the EAR is not needed.

g. **No EAR – Delineation** – The material allows for delineation as an option to the EAR and the delineation option is being used instead of an EAR.

NOTE: This option does not appear on all findings. The material must allow for the use of delineation on the MAC Spec. If the PA created a manual finding, this option would not appear. For this reason, **DO NOT** create a manual finding for materials that allow the use of delineation as a resolution.

h. **Pay Reduction Per Specification** – a pay reduction has been applied per specifications that addressed the material resolution; for example, a structural concrete compressive strength failure 500 psi or less than the minimum required strength.

i. **Reworked and Remixed** – the material represented by the finding has been reworked and remixed and there are samples that represent the material that do not have any findings.

NOTE: When the PA selects a, b, d, e, h or i, the PA's initial recommendation becomes the final resolution and there are no other actions needed by other users such as the DMRE or DCE. The PA should enter the optional final payment information <u>H. Entering the Final Pay Information</u> and the location information <u>I. Entering the MAR Location Information</u>.

5. Select the Save option to save the initial recommendation.

B. Making a Recommendation of EAR, No EAR, or No EAR - Delineation

If the PA selects c, f, or g (EAR, No EAR, or No EAR – Delineation), they should coordinate with the users in the process to ensure the MAR issue recommendations and resolutions are designated.

- 1. After the PA makes initial recommendation, they should notify the DMRE that the finding is awaiting DMRE initial recommendation.
- 2. Once the DMRE makes an initial recommendation, the DCE needs to make an initial recommendation. The PA should not notify the DCE that the finding is awaiting DCE initial recommendation.
- 3. If the DMRE and DCE do not concur, in some cases, the DOC, may need to make an initial recommendation. The finding will indicate if the DOC's initial recommendation is needed. The PA should notify the DOC that the finding is awaiting the DOC's initial recommendation.

C. Processing the EAR or Delineation steps outside of MAC

Once the initial recommendation of EAR, No EAR, or No EAR – Delineation is selected, the process goes outside of MAC. The PA should return to MAC when the final resolution is ready to be documented.

If the Recommendation is **EAR**:

- 1. The Contractor submits the scope of the EAR to the PA
- 2. The PA submits the EAR scope to the DMRE for their review
- 3. The DMRE reviews the scope and makes recommendations to the scope
- 4. The DMRE returns the scope with recommendations to the PA
- 5. The PA returns the scope to the Contractor
- 6. The Contractor performs the EAR
- 7. The Contractor submits the EAR to the PA
- 8. The PA comes back into MAC to continue the process

9. The PA attaches the EAR to the finding (<u>E. Attaching the EAR and other documents to the Finding</u>)

10. The Department makes a final determination if the material must be removed or if all or part of the material can be left in place

11. The PA makes the final recommendation in MAC (<u>F. Making the Final Recommendation from</u> the Finding Details or <u>G. Making a Final Recommendation from the Findings List</u>)

2. If the Recommendation is **No EAR – Delineation**:

- a. The Contractor performs the delineation
- b. The Contractor submits the delineation summary to the PA
- c. The PA comes back into MAC to continue the process

d. The PA attaches the any delineation documentation to the finding (<u>E. Attaching the EAR and</u> <u>other documents to the Finding</u>)

e. The Department makes a final determination if the material must be removed or if all or part of the material can be left in place

f. The PA makes the final recommendation in MAC (<u>F. Making the Final Recommendation from</u> the Finding Details or <u>G. Making a Final Recommendation from the Findings List</u>)

3. If the Recommendation is No EAR:

a. The Department makes a final determination if the material must be removed or if all or part of the material can be place

b. The PA goes directly to making the final recommendation (<u>F. Making the Final Recommendation</u> from the Finding Details or <u>G. Making a Final Recommendation from the Findings List</u>)

D. Making an Initial Recommendation from the Findings List

The PA can make a recommendation for a finding directly from the findings list. By selecting an initial recommendation from the finding listing, the PA has does not have the option to review the information, comments and documents associated with the finding.

I. Entering the MAR Location Information

As part of the PA's responsibilities for processing the MAR issue, they must include the location information on the location tab. The information may not be available until after the final recommendation is complete and the material is removed or partially removed. It must be completed before the finding can be designated as an Exception. This information is used by MAC to enter the location information of the exception on PMCL. Because of this, the MC Reviewer may notify the PA if additional entries are needed or if there are issues with the current location entries.

MAC populates the PMCL Exception with the information from the Location tab.

A. Straightedge Deficiencies

NOTE: When the QC data entry select the **Has Deficiency Readings** option, the test disposition for FM 5-509 will appear as **Pass***. This is because there are no limits set on the test definition on the MAC Spec. So it technically it does pass the targets and limits programming. However, the special programming that detects this selection as an automatic finding indicates it as a failure. If you click on the test disposition, a dialog box will appear describing the test as failing.

B. Ride Number and IRI Deficiencies

For FM 5-549 which utilizes the laser profiler, the failing test disposition is triggered by the test targets for both the Ride Number and International Roughness Index types.

The DOC is no longer required to make recommendations for asphalt pavement surface deficiencies.

Chapter 6 – Earthwork Records System (ERS) MC Review

Some ERS MC Review issues are automatically identified by MAC. The ERS portion of the MC Review appears on the MC Review as a tab with ERS findings. The ERS MC Review process is the same as the functions for MC Review findings as described in this manual.

In order for the ERS findings tab to appear, MC Reviewers may need to recalculate the MC Review. If the tab does not appear upon recalculation, there are no ERS findings yet. Any regular finding detected by MAC such as failing test results or unqualified technician will appear as an automatic finding.

ERS IA Project Reviewers evaluate many items in the ERS data. Not all will appear as an ERS finding in the MC Review. They may find issues with the plots being incorrect. The MAC ERS reports used by the ERS IA Project Reviewers detect issues with gauges, test depth, etc. PAs should expect to coordinate resolving to ensure that they will not result in an ERS finding for example, incorrect plots that result in a missed field density test.

Chapter 7 – Work Order and Permit MC Reviews

With the implementation of Work Order nonstandard JGS (NSJGS), MC Reviews can be conducted per Work Order.

On an MC review with a Work Order NSJGS, each Work Order will have its own tab under the Findings tab. Under each Work Order tab, will be two subtabs, one for ERS findings and one for MC Review Findings.

Each Work Order is meant to function as its own MC Review; however since the PMCL is contract based, it will require only one PMCL to be generated. Because of the nature of the Design Build Phased contracts, the primary reason for Work Order NSJGS, the MC Review may be open for years. MC Reviewers can close Work Order reviews.

A. Closing an Open Work Order MC Review (MC Reviewers)

When an MC Reviewer has determined that all of the work in a specific work order is completed and the data for materials acceptance is completed, they may close the work order MC Review.

When a Work Order is closed:

- No additional samples can be added to the system for that Work Order
- No changes can be made to existing samples
- Existing samples cannot be deleted
- Work Order NSJGS cannot be updated or deleted and entries on the NSJGS cannot be deleted
- The Contractor QC Plan can be updated or deleted since it is contract based and needs to remain open until the PMCL is generated.

In order to close a Work Order MC Review, all findings must have a status of either Excluded, MC Resolved or MAR Resolved.

B. Reopening a Close Work Order MC Review

On a Work Order designated as Closed, the MC Review can select Reopen Work Order option. The Work Order MC Review will be reset to Open. All records that were previously locked down are reopened.

C. Permit Project MC Review

With the implementation of permit project in MAC, an MC Review can now be created for some permit projects, for example, a pedestrian bridge being constructed outside FDOT right of way but crossing over the state highway system. The review and processing of findings is the same for these entries. In most cases, an MC Review for a permit project will not also be Work Order based.

Chapter 8 – MC Review Reports

There are several reports designed to assist the PA and MC Reviewer with identifying MC Review issues. Some are designed for processes related to MC Review, such as open sample reports and other are specific to the MC Review such as Project Findings. Here are the MAC reports and how a PA can use them for MC Review.

A. Missed Frequency

These reports can be found on the Reports Page under the Sample Tab.

1. APL/BABA Tracking Spec Summary

This report provides a list of all the project MAC Specs with a category of APL and BABA tracking and categories that align with the APL Spec categories. It can be used by PAs to determine if there are requirements in MAC that may not have been assigned to their JGS entries. For more information, see the <u>APL Tracking and Materials Certification Review</u> instructions.

2. QCP Materials Versus

This report is specifically for Materials 948 (Flexible Pipe), 967 (Guardrail), and 932FRP (Fiber Reinforced Polymers). It serves two purposes. If there are these material types on the Contractor Quality Control Plan, it identifies if there are samples in MAC for them. These material types are used less frequently and tend to be overlooked. The second purpose is when there are samples, it identifies if the material type is listed on the Contractor QC Plan. This assists the PA with ensuring compliance with **Specifications Section 105**. See the <u>FDOT Contractor QC Plan</u> <u>Review</u> instructions.

3. SMO Certification Summary

Not all MAC Specs with a certification document require the document to be logged into MAC for SMO review. This report provides a list of all the project MAC Specs with a certification MOA that designates it is to be reviewed by SMO. It can be used by PAs to determine if there are requirements in MAC that may not have been assigned to their JGS entries. For more information, see the <u>Certification Documents Reviewed by the State Materials Office</u> instructions.

These Reports can be found under the Project tab.

4. APL Project Tracking Summary

This report sounds similar to the APL/BABA Tracking Spec Summary report, but it differs in that it is specific to a single Project JGS entry. PAs can use this report to see what may require an APL MOA, determine if the requirement applies to their project and if the sampling frequency of 1 per product has been met.

- 5. Asphalt Sample Number Lot Number Report
- 6. Concrete Sample Number Lot Number Report
- 7. Earthwork Sample Number Lot Number Report

The sample number lot number reports work with the material sample numbering systems. The numbering systems are designed so that when the samples appear in the report, it can be relatively easy to see that there is a missed frequency for asphalt plant, structural concrete or Earthwork / Soils lab samples.

Things the PA should watch for are:

- If it appears that a sample is missing within the LOT, check the FDOT Sample Number
 - Samples not following the numbering system will be thrown out of order, maybe at the top or bottom of the list depending on the error
 - CC1001V mistyped as CC101V will sort closer to the top
 - CC1001V mistyped as CC100001V will sort closer to the bottom
- The report is meant to quickly show missed samples with whatever samples exist
 - It cannot identify when samples should have been taken and were not
 - For example, the last four lots of a material were not sampled

8. Reduced Lot Analysis

This report is used by QC Manager and PAs to confirm that a project is eligible for concrete reduced lots as specified in *Specifications Section 346*. Using this report ensures the analysis meets the requirements spelled out in the Specifications consistently across the state.

9. SMO Certification Tracking

This report sounds similar to the SMO Certification Tracking Spec Summary report, but it differs in that it is specific to a single Project JGS entry. PAs can use this report to see what may require a certification document to be reviewed by SMO, determine if the requirement applies to their project and if the sampling frequency has been met.

B. Non-standard Material

These reports can be found on the Reports Page under the Sample Tab.

1. Asphalt Content Test Report

This report was originally developed to identify asphalt content results, particularly those that are failing. Previously, MAC MC Review finding programming related to QC sample failures did not catch all the potential findings. Recent updates have corrected this. The report is still a good summary of the test results: passing, failing or both.

2. Asphalt Roadway Density Report

Like the Asphalt Content Test Report, this report was originally developed to identify asphalt roadway density results, particularly those that are failing. Previously, MAC MC Review finding programming related to QC sample failures did not catch all the potential findings. Recent updates have corrected this. The report is still a good summary of the test results: passing, failing or both.

3. Asphalt Sample Pay Factor Report

Not all users have access to the Close Out Sample comparison package screen. This report can be used to summarize the Pay Factor from many aspects, including by project.

NOTE: The Composite Pay Factor Report for In-Progress Lot is intended for the QC Manager as a way to monitor a LOT that is still in progress and is not intended for Lots that have been completed.

4. Gradation Failure Report

Like the Asphalt Content Test Report and Asphalt Roadway Density Report, this report was originally developed to identify asphalt gradation results, particularly those that are failing. Previously, MAC MC Review finding programming related to QC sample failures did not catch all the potential findings. Recent updates have corrected this. The report is still a good summary of the test results: passing, failing or both.

5. Rolling Straightedge Summary

This report is designed to provide a summary of the rolling straightedge samples. PAs can use this report to summarize all the samples, or just the samples with deficiencies.

These Reports can be found under the Project tab.

6. All Materials Compares

This report is not specifically for project information and does not necessarily indicate nonstandard material. It can be used by the PA to summarize any existing comparison package on the project and if it compared or not. It will summarize the comparisons by facility id to assist in determining if non-comparisons may be related to the production facility.

7. Asphalt Segregation Report

This report provides a summary of any asphalt segregation samples and results.

8. Concrete Pavement Core-Out Averages

Prior to MAC implementation, PAs had to develop their own summary for concrete pavement cores and designate pavement deficiencies. Now that the test is recorded in MAC, this report is designed to document both MC Review deficiencies and information required for Final Estimates average thickness calculations. By utilizing the report, PAs do not need to develop an alternate method. In fact, this is discouraged. PAs should utilize this report to ensure the calculations are consistent on every project. Also, there are no failing test results for these samples. PAs need to generate this report when the concrete pavement is completed and create manual findings for any deficient thicknesses left in place.

9. Concrete Project Test Results

This report summarizes the finalized concrete sample test results and highlights any that do not mee the Specification limits. MAC should be flagging these samples. The report is meant to provide the PA with an overall summary. It also assists with failures to help determine if a failure might be eligible for a pay reduction per Spec or if it severe enough to require a structural analysis. The report itself cannot be used for this determination but it does indicate if the psi portion of the determination is < or > 500 psi.

10. Earthwork Sample Analysis

This report provides a summary of finalized earthwork / soils lab samples including graphs of any proctor curves. It highlights issues with the samples in bold, red font.

11. ERS – Base Thickness Report

Like the Concrete Pavement Core-Out Averages report, the ERS – Base Thickness report is intended for both MC Review and Final Estimates purposes. It differs in three ways:

- Instead of PAs having to come up with their own calculations, PAs previously used the Construction ENGMENU program for the Final Estimates Final Report
 - This report replaces that process and entries into ENGMENU are no longer required
- It can be generated as the project is progressing for issues related to the ERS Project or PA functions or it can be generated at the end of the project for Final Estimates payment purposes
 - Use the Earthwork Office View for on-going monitoring
 - Use the Estimates Office View for the final report that replaces what would have been generated by ENGMENU
- Samples with deficient thickness are flagged as findings in the MC Review
 - PAs do not need to create manual findings

12. ERS – Density

This report provides a summary of earthwork ERS field samples. It does include information for samples that are not yet finalized to assist the PA with determining if a sample is open. It highlights many issues, including many of the paper logbook review items that may not be an MC Review issue.

C. Open Samples

These reports can be found on the Reports Page under the Sample Tab.

1. Open Sample Report

This report is designed for the PA as a way to determine open samples. There is no indicator on any sample in MAC that states if the sample is "open" or "closed". It is a business definition based on whether the sample has completed all required steps. Some of those steps are within the sample life cycle. For some samples, there are additional steps after the samples are finalized. See the <u>Project Sample User Manual</u> Chapter 1 for more information. The report has many options. For a PA who wishes to find all the open samples on a contract or project, the following options should be selected:

- 1. Contract or Project Id
- 2. Sample Status = All But Finalized
- 3. Missing Comparison/Resolution = Both

Additional filters can narrow down the list to a specific subset. For example, if the PA is looking for all the MAC Material 346 project samples that are open, so they can finalize them:

1. Contract Id – concrete project sample comparison packages can cross FPNs if they are in the same contract.

2. Sample Status – Pending Finalization

3. Material IDs – 346 – Portland Cement Concrete or 346 – Structural Portland Cement Concrete, depending on the material on your project.

D. Qualifications

There is one report under the Projects tab that is specific to asphalt or ERS samples with a Witnessed By TIN.

1. Witnessed by Technicians

This report summarizes the samples with a requirement to enter a Witnessed By TIN. It will flag instances when the QC Technician's TIN and the VT Witnessed By TIN are the same TIN.

E. MC Review Reports

These reports sound similar and appear to be for the same thing, but they are for different purposes. Some reports are for all findings, some are for those promoted to MAR and some are for those that have Exceptions created.



1. MCR – Cert Process Time

This report is intended for MC Reviewers and tabulates the time for processing the Project Materials Certification Letter (PMCL). PAs can review it to determine how long it takes the District Materials and Research Office, the State Materials Office or both to send the PMCL once it has been generated.

2. MCR – Exception by Category

This report summarizes any Exception and groups by Exception Categories of Missed Frequency, Non-Standard Materials or Qualification. While this report can be generated for a specific project, it is meant to be used by the Materials Offices for feedback to identify potential problem areas that can be addressed by improvements in the Materials Certification review process.

3. MCR – Exceptions Report

This report is designed to summarize the Exceptions for a specific project or the managing districts of projects. It is a subset of the MAR findings (link) that have had an Exception created.

4. MCR – MAR Findings

The purpose of This report is to summarize and track turnaround times for project findings that have been Promoted to MAR. It shows the recommendation/ resolution status and the user who made the recommendation or resolution. It can also be run on a district basis for the purpose of tracking statuses district wide. PAs can use it to see what the latest status is of each recommendation or resolution. It is helpful with findings awaiting recommendation or resolution but can be generate for both open and closed findings.

5. MCR – MAR Process Time

Like the MCR – MAR Findings report, this report tracks MAR findings recommendation and resolution statuses, but it has a different purpose. While the MAR Findings report lists detailed information on each finding, like the finding description and users performing the recommendations and resolutions, this report is focused on how long it takes the Department (both the PA and Materials personnel) to process a finding. It is intended to assist the PA and Materials personnel with ensuring findings are being processed in a timely manner.

6. MCR – Project Findings

Like the MCR Exceptions report and the MAR Findings report, this report provides detailed information on findings and their statuses. Those are both subsets of this report. This report allows the PA to review all findings. Here is a visual depiction of what each report includes.
