## MPOAC Bike Ped Workgroup Charge

### Name

The MPOAC created a Bike Ped Workgroup and established its membership and purpose to include the broader concept of complete streets. Does the group want to rename itself to capture the broader, more-encompassing idea of complete streets or retain the bike/ped focus?

### Purpose

The purpose of the Work Group is to identify and share best practices in Florida related to complete streets.

### Process

The Work Group will meet in person and by conference call between March 2017 and June 2019. In its discussions and deliberations of these topics the Workgroup will be guided by and work to develop recommendations in the context of the following:

- The adopted MPOAC vision, mission statement and principles;
- The guidance contained in the adopted MPOAC Strategic Directions 5 year plan.

As the process develops, the Workgroup will provide quarterly updates to the Staff Directors and the MPOAC Governing Board and receive input and guidance on their work.

It is anticipated that the Work Group will meet face to face at MPOAC quarterly meetings and by conference call/web meeting. The Executive Director in consultation with the Workgroup Host and workgroup members will establish a meeting schedule. The Workgroup should expect to present quarterly updates or reports to the MPOAC Governing Board as needed.

The Workgroup will be guided by the consensus guidelines and its members should strive for agreement on possible draft recommendations to bring to the MPOAC Governing Board. The Workgroup will receive feedback and guidance from the Governing Board and the Staff Directors on early draft recommendations.

### **Work Plan Tasks**

1. Establish categories for which best practices related to Bike Ped/Complete Streets will be identified and assign a work group member to each category and schedule presentation of candidate best practices for specific work group meeting dates (June 2017, October 2017, or January 2018). A draft list follows:

2. Develop a process to identify a list of potential best practices for each category
  - a. Committee Host creates a survey to identify activities for each best practice category within each MPO planning area and FDOT district; distributes to MPO directors and FDOT secretaries
  - b. Committee Host shares survey responses with assigned committee member for each category
  - c. Committee member assigned to category reviews responses, creates a summary report for the committee, and identifies 3-5 potential best practice candidates; schedules a presentation of these items at the established committee meeting
  - d. Committee hears presentations and votes to include/exclude candidate as a best practice
  - e. Assigned committee member populates a one-page at a glance summary for each selected best practice
3. Committee Host compiles all approved best practices in a final summary document for review and approval by the committee in March 2018.

### **Potential Future Tasks:**

- Review the results of the first MPOAC Best Practices Workshop and recommend how to conduct future workshops.
- Review and make recommendations on whether the MPOAC should establish, support and share with MPOAC members an online repository of best practices and successful strategies related to bicycle and pedestrian issues in Florida and nationally.
- Recommend whether the MPOAC should establish a best practices award and recognition program associated with the Best Practices Workshops for work by Florida MPO/TPOs related to bicycle and pedestrian issues.
