Overview of Committee Representation

- Committee Membership
 - Member MPOs represent 63% of the overall MPOAC membership
 - A majority (87%) of MPOs have identified and confirmed an alternate
 - A majority (73%) of MPOs (voting members or alternates) participated in the outreach survey
 - At least one MPO within each FDOT District (District 4 has the most with four member MPOs)
- Friends of the Committee
 - A majority (80%) of the non-member MPOs have identified and confirmed a staff member to serve as a Friend of the Committee
 - Serves as Point of Contact (POC) for Freight Priorities Program
