

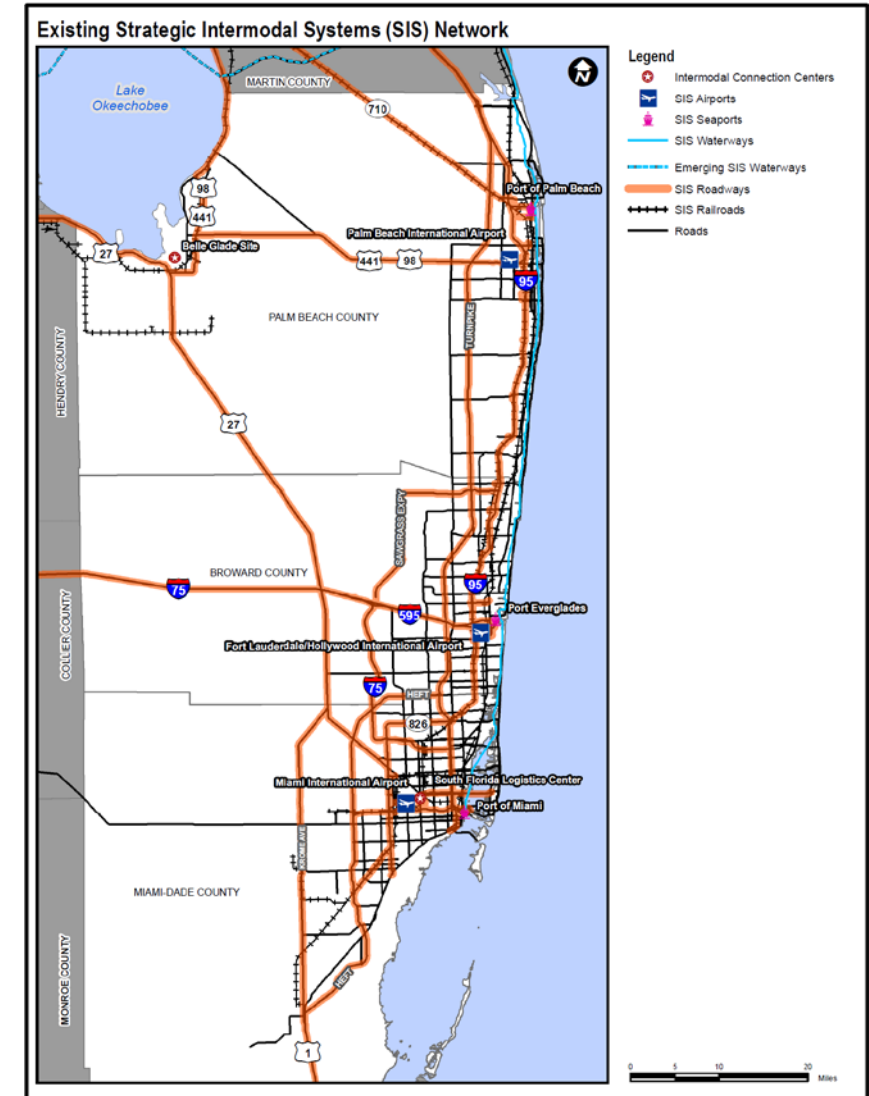

- Summarizes and incorporates key freight and logistics initiatives to help position the region as a global logistics hub

- Promote regional freight mobility

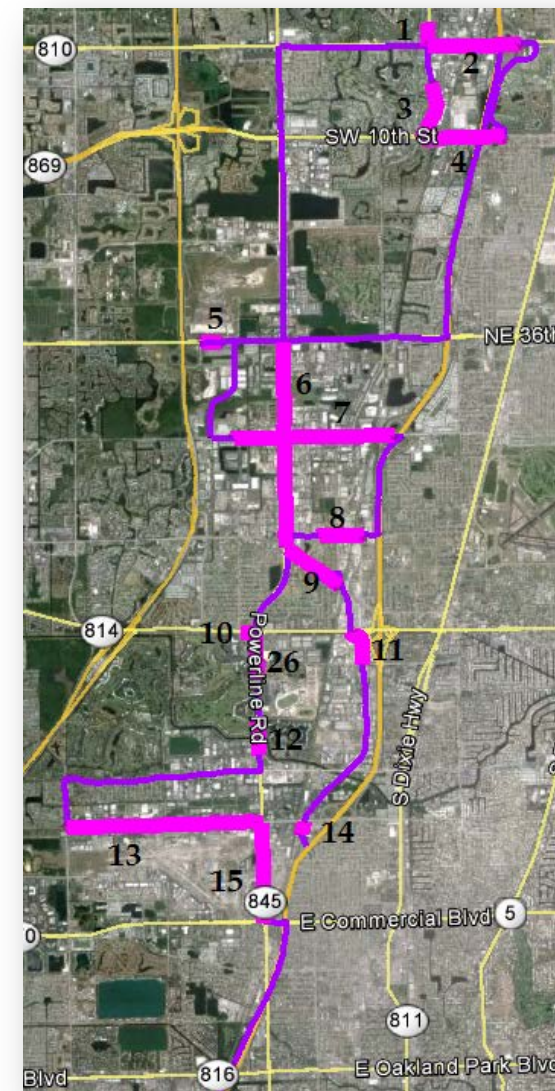
SE FL Regional Freight Plan Hotspot Analysis



Observation	Recommendation
Right turn radii are too short for trucks	Lower curbs, restripe, or widen radius
Long queues and unused green time	Optimize signal timing
Access point density	Merge and close some access points
Improper or confusing signage	Replace or remove signage
Deteriorated pavement	Repave and improve conditions
Roadway not aligned	Restripe lanes
Slow left turns	Move stop lines back

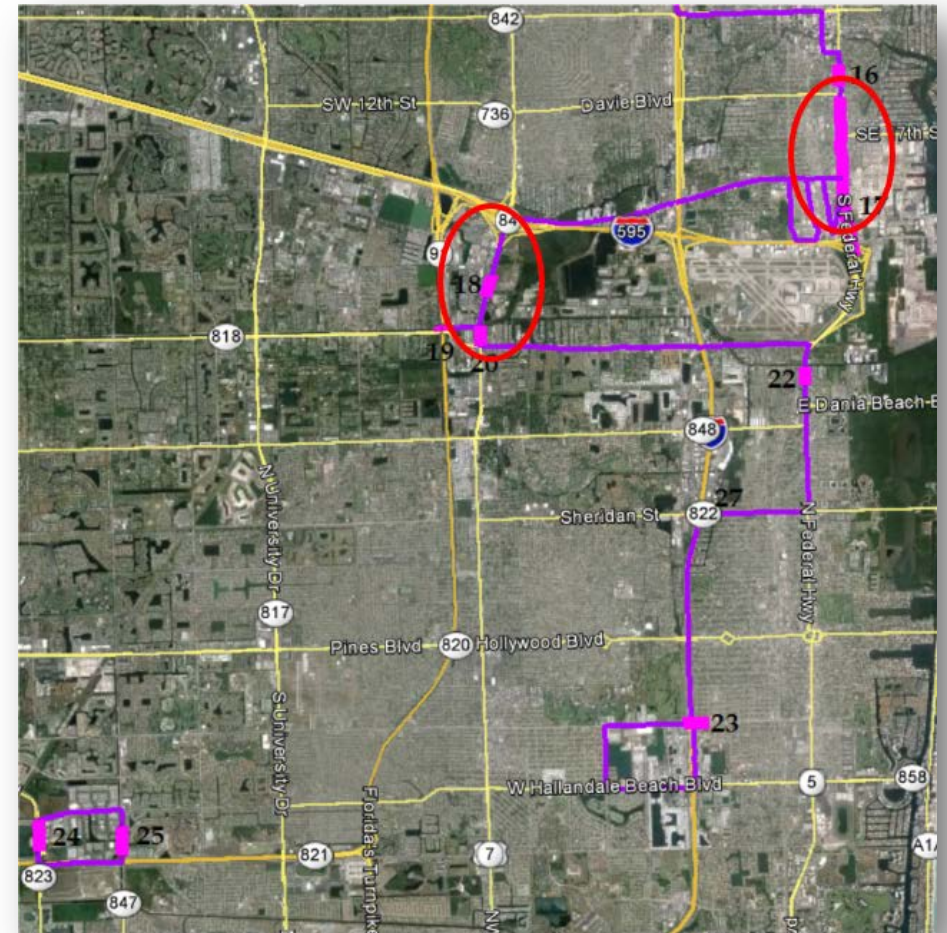

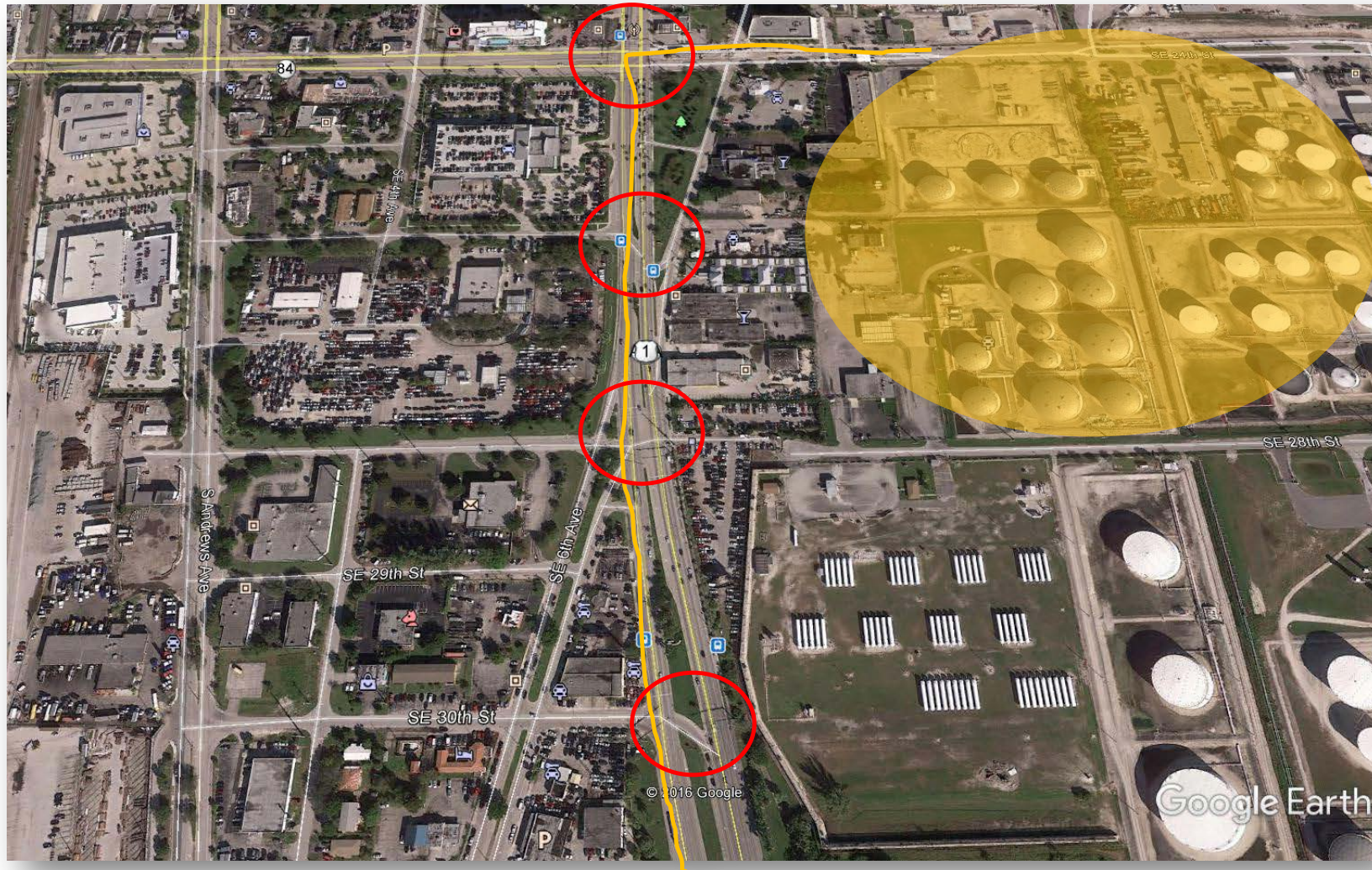


Location 17: US 1 – Davie Blvd to Eller Dr/I-595

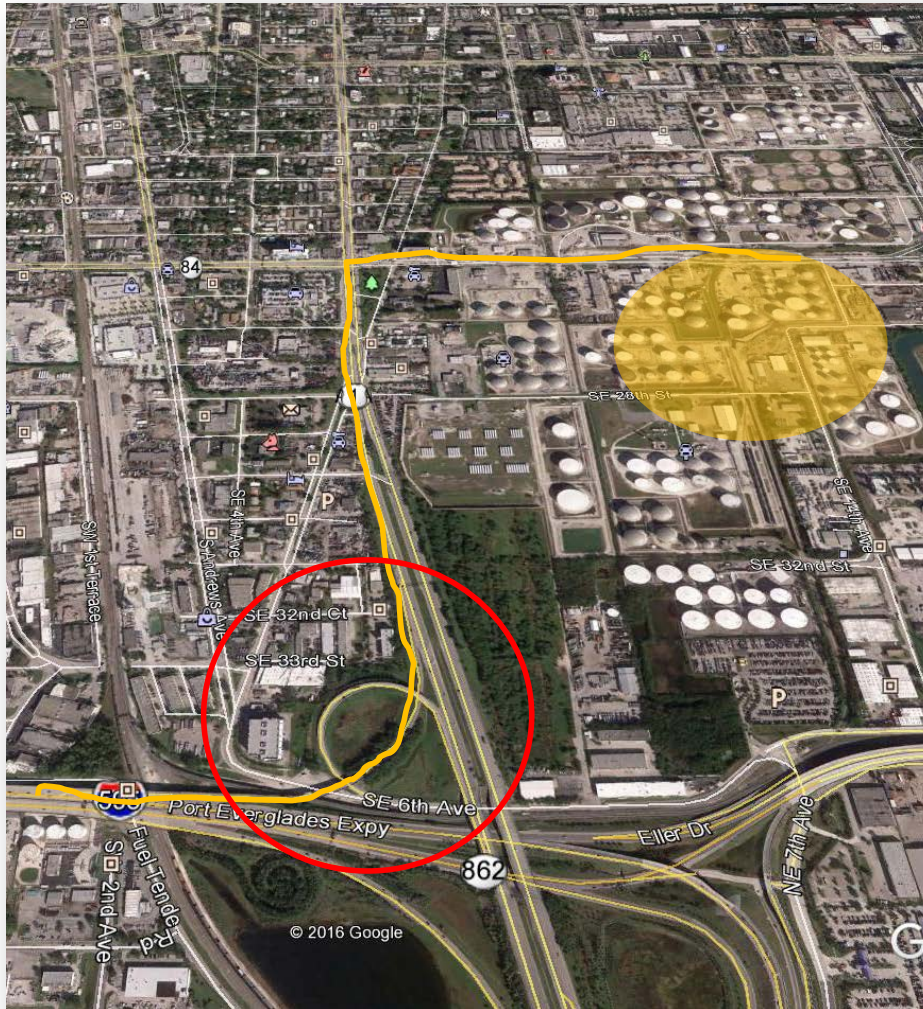
Observation	Recommendation
NB US1 at SR84 curb lane is a shared right turn/through lane	Look at possibility of providing an exclusive right turn lane or a right turn bay at least 500 feet long
Signal of US1 at SE 6 th Ave causing extra delay to US1 through traffic	Study the possibility of removing the signal and redirect traffic
Drive thru traffic going to the Starbucks at Davie Blvd and US1 backed up to the US1 curb lane.	Close entrance to Starbucks on US-1 and only allow access on side streets
Signals of US1 at SR84, SE 17 th St, and Davie Blvd are not coordinated well	Improve signal coordination along the three major signals

Concepts to be Evaluated

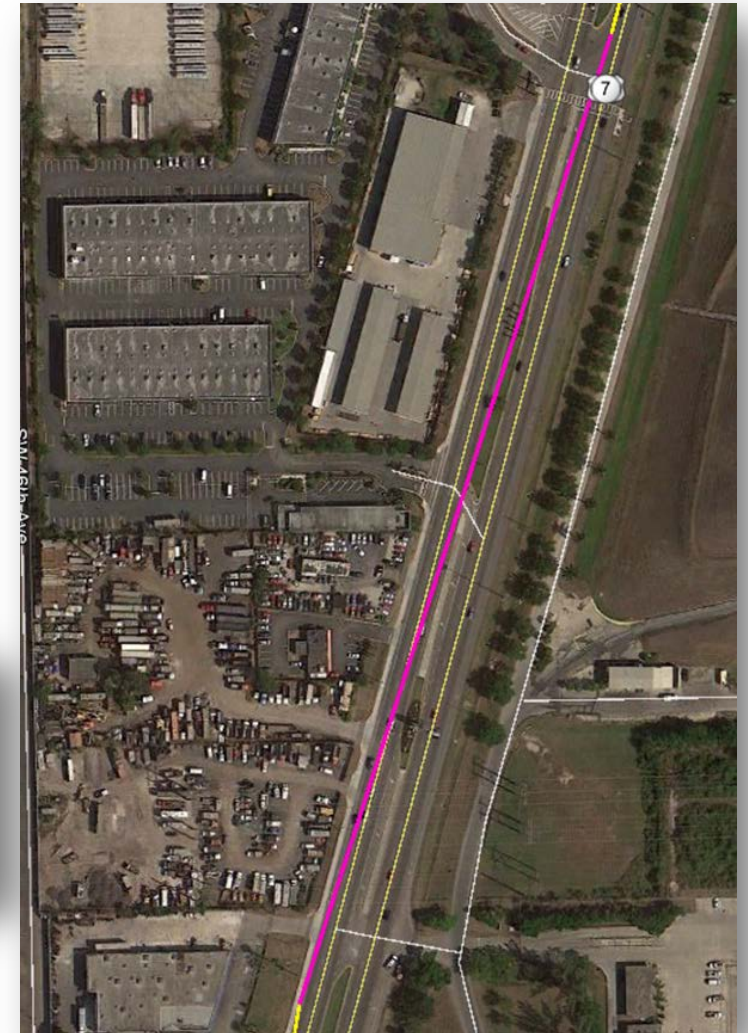
- Southbound US 1 to I-595 Westbound On-Ramp
 - FDOT's Concept Development (CD) team will look at options of adding 2 lanes to the on-ramp and/or merge location with I-595
- US-1 at SE 28th Street
 - CD team will look at up to 2 concepts to improve traffic flow through the intersection
- US-1 at SE 30th Street
 - CD team will look at up to 2 concepts to improve the traffic through the intersection

Planned Activities

- Data Collection – Complete
- Conduct Traffic Forecasting – Spring 2017
- Conduct Operational Analysis – Spring 2017
 - Construction benefit/cost ratio for each alternative
- Present Recommendations – Summer 2017
- Submit Report to ERC for Review – Summer 2017
- Final Report and Concept Plans – Summer/Fall 2017

Location 18: US 441/SR 7 at Oakes Rd

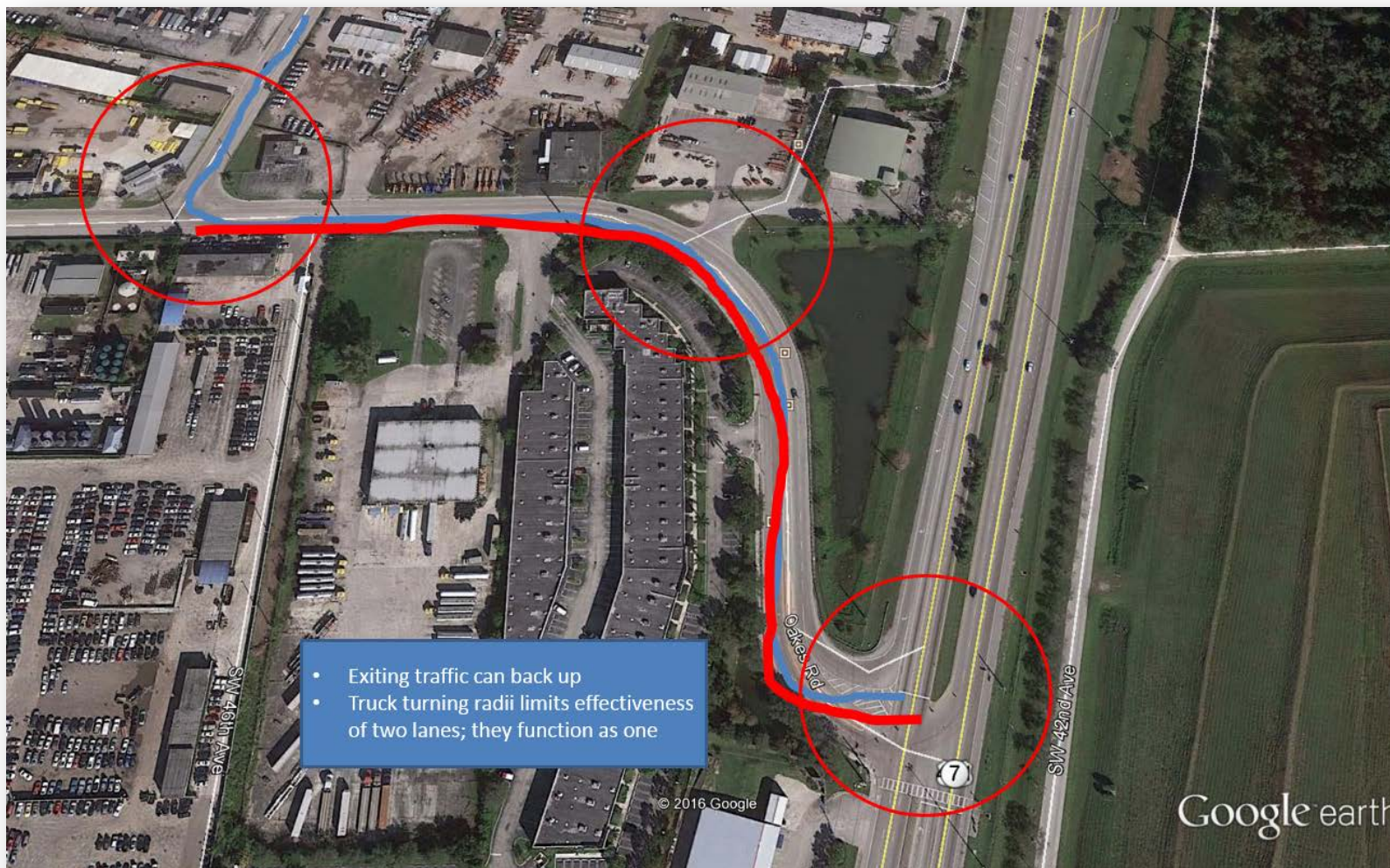
Observation	Recommendation
EBLT trucks spend longer than usual time to pass the intersection of SR7 at Oakes causing extra delay for through traffic on SR7	Make dual left turn on EB approach
High number of access points and side streets on west side of SR7	Merge and reduce access points

Concepts to be Evaluated

- US 441 at Oakes Road
 - CD team will look at concepts to improve traffic flow at this intersection with emphasis on truck access to/from Oakes Road
- Oakes Road and SW 46th
 - CD team will look at concepts to improve traffic flow at this intersection with emphasis on truck access to/from SW 46th
 - FDOT's Traffic Operations team will look at potential signalization improvements at this intersection
 - FDOT's Drainage team will look at possible improvements to SW 46th in response to flooding concerns

- Conduct Traffic Forecasting – Spring 2017
- Conduct Operational Analysis – Spring 2017
 - Construction benefit/cost ratio for each alternative
- Present Recommendations – Summer 2017
- Submit Report to ERC for Review – Summer 2017
- Final Report and Concept Plans – Summer/Fall 2017

Next Steps & Continuing Efforts

Stakeholder Outreach

- District 4 continues to engage the freight stakeholder community in an effort identify critical freight bottlenecks in our region
- Targeted stakeholder outreach meetings, industry forums, MPO advisory committees, and targeted listening sessions will be utilized to identify critical bottlenecks and issues affecting the freight community in District 4
 - Participating and supporting Broward MPO's FTAC
 - Engaging local economic development agencies and universities

Research Projects/Planning Studies

- Analysis of Freight Transport Strategies & Methodologies
 - Research project to look at existing/potential freight data and support tools to better identify and provide decision support tools related to freight project development
- Freight Safety/Truck Crash Hotspot Analysis
 - This project will identify potential truck safety projects/hotspots through a statistical analysis based on existing FDOT crash data
- Freight Model Enhancements
 - This study will look at existing freight modeling efforts and examine methods to build on and improve the accuracy of freight modeling at the District level
