# **Bylaw Changes**



#### May 21st Post-Meeting Survey Results

#### Most people voted for:

- a 3 year committee member cycle
- application submissions for replacing current committee members
- some sort of guidelines/benchmarks to remain on committee attendance being primary guideline

#### Most people felt:

- that the committee is relevant to current issues, but a few wanted more discussion on industry trends/"news"/topics looking into the future
- that the freight modes are represented, with a few comments that aviation is lacking representation
- that they are satisfied with their role, but many comments about how to improve, most commonly the desire for a yearly face-toface meeting



#### **Bylaws – Commitment Timeline & Leadership**

(1) FLFAC committee membership will take place on a three (3) year cycle. In order to always have an overlap of veteran and new members, the committee membership cycles will be staggered. Every one and a half (1.5) years, the half of the committee members who have been on the board for three (3) years (veteran members) will be replaced. To set up the staggered cycle of membership, we will do a special application process to allow current FLFAC committee members to reapply to remain on the committee for an additional half cycle or one and a half (1.5) years.

FLFAC committee membership - three (3) year cycle

#### Applications and Elect Chair and Vice-Chair - half cycle or <u>every one</u> and a half (1.5) years

The FLFAC shall at its first meeting of the <del>calendar year</del>half <u>cycle elect</u> a Chair and Vice-Chair. The Chair and Vice-Chair shall take office upon <u>election, and</u> shall serve until the completion of next regular election which shall be held at the first meeting in the first quarter of the calendar yearnext half cycle, or until a successor is thereafter elected, whichever event shall first occur. The Chair and Vice-Chair must at all times during their term of office be members of the FLFAC.

(3) In order to remain on the committee, members must attend at least half of the yearly meetings. Members are expected to be at every meeting, but due to scheduling conflicts, it is permissible to miss several meetings with notice to the board. If a member is consistently failing to attend meetings and misses more than half of the yearly meetings with no notice, he or she will be asked to step down, and a replacement will be found through the process identified in Section 2 (c) (2).



#### **Bylaws – Committee Replacements**

In addition to the FLFAC there will be a subcommittee <u>contact list</u> further identified as the Florida Freight Executive Affiliates. The sub-committee members<u>list</u> will <u>be notified of all FLFAC committee</u> <u>meetings, and may be asked to serve as alternatives replace members of</u> to the FLFAC in the event that they suspend participation, fail to meet annual attendance requirements, or depart their organization. Details for this process are outlined in Part (2) below.

(2) If a vacancy occurs in for the FLFAC, the Governing Board, shall identify a member of contact from the Florida Freight Executive Affiliates <u>list Committee</u> to serve as a replacement FLFAC committee member, if appropriate, until the time set for the beginning of the FLFAC Governing Board meeting held in the third quarter of the calendar yearnext half cycle, or until a successor is thereafter elected, whichever event shall first occur. If no contact from the Florida Freight Executive Affiliates list fills the needed gap in representation to keep the FLFAC a cross-section of public and private sector freight stakeholders, then the Governing Board may request additional applications for a replacement FLFAC committee member.

The procedure to replace members of the committee after three (3) years will involve application submissions. Applications will be made available on FreightMovesFlorida.com and interested parties will be able to submit applications to the Governing Board during a specified timeframe. Decisions on FLFAC committee member replacements will be made by the Governing Board.

(3) In order to remain on the committee, members must attend at least half of the yearly meetings. Members are expected to be at every meeting, but due to scheduling conflicts, it is permissible to miss several meetings with notice to the board. If a member is consistently failing to attend meetings and misses more than half of the yearly meetings with no notice, he or she will be asked to step down, and a replacement will be found through the process identified in Section 2 (c) (2).





1.5 Years





Every half-cycle (1.5 Years), the Committee will vote on a new Chair/Co-Chair, and half of the committee members will be replaced using an application process

The members that will be replaced will be those that have already served two half-cycle terms, or one full committee cycle



#### How will this impact you?

 This first committee turn-over will be unique, and will set up the staggered committee membership

- Current FLFAC members will be allowed to reapply to remain on the committee, and anyone not currently a FLFAC member can apply to be considered
- Current FLFAC members who reapply and are reselected will remain on the committee for another 1.5 years
- New FLFAC members who are selected will remain on the committee for 3 years




# Freight Mobility & Trade Plan (FMTP) Update

 The Freight Mobility & Trade Plan (FMTP) is a comprehensive plan that identifies freight transportation facilities critical to the state's economic growth and guides multimodal freight investments in the state







#### **FMTP Refresher**

- Helps local jurisdictions measure progress using plan metrics, develop grant applications, and new freight-related funding strategies
- Helps local chambers of commerce understand freight's share of the economy, logistics efficiency, and the economic strengths and challenges associated with freight in Florida
- Lets manufacturers know about the freight infrastructure availability and the business climate of the state
- Gives insight to the general public, local officials, news outlets and the trade/business media about freight's contribution to daily life and the economy
