On behalf of the Florida Department of Transportation (FDOT) District Four, you are invited to a Public Information Workshop to learn about the proposed improvements for the above referenced project.

The Public Information Workshop is scheduled for Thursday, March 5, 2020 from 5:30 p.m. to 7:30 p.m. at the Jupiter Community Center located at 200 Military Trail, Jupiter, FL 33458. The workshop will have an open house format and staff will be available to answer questions and provide assistance at any time during the workshop.

The purpose of this meeting is to display the current proposed design plans for the bridge replacement project for the US 1 bridge over the Loxahatchee River. A full bridge closure is planned to facilitate the construction of the new bridge. Bridge traffic will be detoured to Alternate A1A for approximately twenty months. The Department's goal is to minimize impacts of the bridge closure to the community to the greatest extent possible. This will include a commitment to provide temporary intersection improvements along the detour route to improve traffic flow during construction. Locations of the intersection improvements include Indiantown Road at Alternative A1A, Indiantown Road at US 1 and Old Dixie Highway/Alternate A1A at US 1.

Notices are being sent to all property owners and tenants located within 300 feet of the project and to other public officials, regulatory agencies, organizations, and individuals interested in the project. Attached is a copy of the Public Information Workshop Flyer, which includes a project location map and other important information about the project.

The Florida Department of Transportation (FDOT) District Four, will conduct a Public Information Workshop regarding the US 1 Bridge Replacement project in Jupiter. This workshop will have an open house format with representatives available to answer questions. Design plans and project information will be available for public viewing. Please stop by at your convenience.

### PROPOSED IMPROVEMENTS

- Bridge replacement that provides improved navigation clearances of 35 feet vertical and 125 feet horizontal
- Bicycle lanes and sidewalks on both sides of the bridge
- Intelligent Transportation Systems (ITS) to be provided. ITS uses technology to improve traffic flow which makes a facility safer and less congested.
- Improve traffic operations at Alternate A1A and Dixie Highway by reconfiguring intersection and adding a traffic signal

### TRAFFIC CONTROL

A full bridge closure is planned to facilitate the construction of the new bridge. Bridge traffic will be detoured to Alternate A1A (State Road 811) for approximately twenty months. The Department's goal is to minimize impacts of the bridge closure to the community to the greatest extent possible. This will include a commitment to provide temporary intersection improvements along detour route to improve traffic flow during construction (refer to map to the right).

- Old Dixie Highway/ Alternate A1A / US 1
