#### Questions/Discussion

 Comment: Charlene – RAISE (Rebuilding American Infrastructure with Sustainability and Equity) notice of funding opportunities has been released which includes EV:

- Q: The proposed EV registration fees may discourage EV adoption from an equity perspective. If the state moves forward with these fees, low income groups should be exempt from these fees.
  - Jennifer we can note this comment. We will also need to monitor where the senate bill lands but this is something we will note.
- Q: Utilities are critical to the development of infrastructure and ensuring power supply, can you discuss more about how you are working with the PSC that will support the infrastructure plan?
  - Jennifer We worked closely with PSC, and on October 21, 2020 PSC conducted a workshop to discuss comments received pertaining to the type of regulatory structure necessary for the delivery of electricity to EV charging infrastructure. The PSC is monitoring the various utility pilot programs to help inform how to address utility participation in the charging service marketplace.
- Q: Gregor- If the plan is to support EV implementation, would a user fee not disincentivize?
  - Jennifer It is not a fee they wouldn't pay if they were using a gas vehicle, it is all about how the fee is structured. The fee would equal the amount a typical ICE vehicle driver would pay.
- Q: Public comments are due in 30 days?
  - Jennifer correct.
- Q: Fred Do you see the proposed EV funding in the American Jobs act impacting the Master Plan at all?
  - Jennifer I'm not sure, this is something I am not familiar with, and we will investigate.
- Q: Can local government sustainability office help?
  - Jennifer not sure, but we'll look into local government coordination further.
- Q: Rena Does this plan involve selection of vehicle type? Are the charging stations for EV ubiquitous? If not how will this be addressed?

- Jennifer We looked at existing publicly available and universal type charging and proprietary charging for evacuation. We are aware that most existing Florida EV owners use proprietary charging.
- Q: Prentiss How are you engaging commercial companies interested in building out EVSE?
  - Jennifer Many stakeholders have reached out and we have had productive conversations. We are keeping it a 2-way conversation.
- Q: Janet What methodologies are you looking at for calculating fees?
  - Jennifer The department does not have authority to calculate the fees. This will be done through statute or DHSMV.
- Q: Eric There was a strong emphasis in the statute to engage commercial interests in the plan. Do you feel you have sufficient market based / competitive solutions in this plan?
  - Jennifer I feel we do have that in the existing plan-we will address this in future working groups to make sure all stakeholders are involved.
- Comment: Court According to the EIA if Florida would go EV tomorrow (all vehicles) residents would pocket about \$20 billion in fuel cost not spent on gasoline. It becomes imperative to make the transition as rapidly as possible.
  Jennifer Agree.
- Q: Phil Could you talk about the distribution of the EVMP beyond to Governor and Legislature. For example, on regional coordination, will you share with transportation agencies in other Southeastern states?
  - Jennifer Yes, if we get asked—we will make the plan publicly available to any parties interested.
- Q: Prentiss When evacuation is required and everyone is charging at the same time, how will the grid handle that?
  - Jennifer We are looking into it, and we acknowledge that it will be a transition over time. Will have to build in the back-up power.
- Q: Court Under incentives for EV adoption why would a gas tax increase not be an incentive for EV adoption?
  - Jennifer There has not been a successful gas tax increase proposal in years—it is not a popular proposal.
