



Strategic Intermodal System Commercial Service Airports

To plan for an efficient and safe transportation network in Florida, the state legislature and Florida Department of Transportation (FDOT) developed the Strategic Intermodal System (SIS). As part of the SIS, there are specific elements that have been identified as critical to the economic success of Florida. One of these elements are Commercial Service¹ (CS) airports, which serve two main purposes; to move significant numbers of domestic and international passengers as well as cargo throughout the State of Florida.

The adjacent table lists the CS airports in Florida and their SIS designations as defined by the criteria put forth by FDOT.

Seven CS airports are on the SIS, while eleven have been designated as Strategic Growth and two have no designation.


