



Strategic Intermodal System General Aviation Reliever Airport

In order to plan for an efficient and safe transportation network in Florida, the state legislature and Florida Department of Transportation (FDOT) developed the Strategic Intermodal System (SIS). As part of the SIS, there are specific elements that have been identified as critical to the economic success of Florida. One of these elements are General Aviation Reliever (GAR) airports, which serve as potential "reliever airports" to the commercial service airports throughout the State of Florida.

The adjacent table lists all GAR airports within Florida and their SIS designations as defined by the criteria put forth by FDOT.

Provide relief or additional capacity to commercial service airports when they reach capacity
